THEY SPECIALIZE IN REPRESENTING MANUSCRIPTS AIMED AT YOUNG READERS, FROM PICTURE BOOKS TO MIDDLE GRADE AND YOUNG ADULT NOVELS. AGENTS NOT ONLY ASSIST WITH MANUSCRIPT DEVELOPMENT BUT ALSO NEGOTIATE CONTRACTS AND SECURE BETTER PUBLISHING DEALS. ADDITIONAL AGENCIES TO CONSIDER

BEYOND THE TOP-TIER AGENCIES, MANY SMALLER LITERARY AGENCIES SPECIALIZE IN CHILDREN'S BOOKS AND ACCEPT SUBMISSIONS THROUGHOUT 2023. RESEARCHING EMERGING AGENTS CAN PROVIDE MORE PERSONALIZED ATTENTION AND OPPORTUNITIES FOR NEW AUTHORS.

HOW TO PREPARE YOUR SUBMISSION

PREPARING A SUBMISSION PACKAGE THAT MEETS THE EXPECTATIONS OF CHILDREN'S BOOK AGENTS IS A CRITICAL STEP IN THE PUBLISHING PROCESS. A WELL-CRAFTED SUBMISSION CAN SIGNIFICANTLY IMPROVE THE CHANCES OF REPRESENTATION.

ESSENTIAL COMPONENTS OF A SUBMISSION PACKAGE

MOST CHILDREN'S BOOK AGENTS REQUIRE THE FOLLOWING MATERIALS:

- **QUERY LETTER:** A CONCISE AND COMPELLING INTRODUCTION TO THE MANUSCRIPT AND THE AUTHOR'S BACKGROUND.
- **SYNOPSIS:** A BRIEF SUMMARY OUTLINING THE PLOT, THEMES, AND TARGET AUDIENCE OF THE BOOK.
- **MANUSCRIPT SAMPLE:** REQUESTED PAGES OR THE FULL MANUSCRIPT, DEPENDING ON AGENT GUIDELINES.
- **AUTHOR BIO:** RELEVANT INFORMATION ABOUT THE AUTHOR'S EXPERIENCE AND CREDENTIALS.

TAILORING YOUR SUBMISSION FOR CHILDREN'S BOOK AGENTS

CUSTOMIZING SUBMISSIONS TO ALIGN WITH EACH AGENT'S PREFERENCES IS ESSENTIAL. REVIEW AGENT LISTINGS AND AGENCY WEBSITES CAREFULLY TO UNDERSTAND THEIR SUBMISSION REQUIREMENTS, PREFERRED GENRES, AND MANUSCRIPT FORMATS. ENSURING THAT THE MANUSCRIPT IS POLISHED AND AGE-APPROPRIATE DEMONSTRATES PROFESSIONALISM AND RESPECT FOR THE AGENT'S TIME.

SUBMISSION GUIDELINES AND BEST PRACTICES

FOLLOWING SUBMISSION GUIDELINES PRECISELY IS CRUCIAL WHEN TARGETING CHILDREN'S BOOK AGENTS ACCEPTING SUBMISSIONS IN 2023. AGENTS RECEIVE NUMEROUS QUERIES AND MANUSCRIPTS, SO ADHERING TO THEIR INSTRUCTIONS IMPROVES THE LIKELIHOOD OF CONSIDERATION.

COMMON SUBMISSION GUIDELINES

WHILE SPECIFIC REQUIREMENTS VARY, MOST AGENTS EXPECT:

- SUBMISSIONS VIA EMAIL OR ONLINE FORMS ONLY, UNLESS OTHERWISE STATED.
- MANUSCRIPTS FORMATTED IN STANDARD INDUSTRY STYLE: DOUBLE-SPACED, 12-POINT FONT, AND CLEAR MARGINS.
- QUERY LETTERS LIMITED TO ONE PAGE, WITH NO ATTACHMENTS UNLESS REQUESTED.
- COMPLETE MANUSCRIPTS FOR PICTURE BOOKS AND PARTIALS OR FULL MANUSCRIPTS FOR MIDDLE GRADE AND YOUNG ADULT NOVELS.

TIPS FOR A SUCCESSFUL SUBMISSION

TO MAXIMIZE SUCCESS WITH CHILDREN'S BOOK AGENTS ACCEPTING SUBMISSIONS 2023, CONSIDER THESE BEST PRACTICES:

- RESEARCH EACH AGENT'S RECENT SALES AND CLIENT LIST TO ENSURE ALIGNMENT WITH YOUR BOOK'S GENRE AND STYLE.
- PROOFREAD SUBMISSIONS METICULOUSLY TO ELIMINATE TYPOS AND GRAMMATICAL ERRORS.
- FOLLOW UP RESPECTFULLY IF NO RESPONSE IS RECEIVED AFTER THE AGENT'S STATED RESPONSE TIME.
- BE PATIENT AND PREPARED FOR REJECTION AS PART OF THE SUBMISSION PROCESS.

WHAT TO EXPECT AFTER SUBMISSION

UNDERSTANDING THE POST-SUBMISSION PROCESS HELPS AUTHORS MANAGE EXPECTATIONS AND PLAN NEXT STEPS EFFECTIVELY. RESPONSE TIMES CAN VARY WIDELY AMONG CHILDREN'S BOOK AGENTS ACCEPTING SUBMISSIONS IN 2023.

RESPONSE TIMES AND COMMUNICATION

MOST AGENTS SPECIFY ESTIMATED RESPONSE TIMES, RANGING FROM A FEW WEEKS TO SEVERAL MONTHS. SOME AGENTS NOTIFY ONLY IF INTERESTED, WHILE OTHERS PROVIDE FIRM REJECTIONS. MAINTAINING PROFESSIONALISM IN ALL CORRESPONDENCE IS ESSENTIAL FOR FUTURE OPPORTUNITIES.

POSSIBLE OUTCOMES

AFTER REVIEWING SUBMISSIONS, AGENTS MAY:

- REQUEST THE FULL MANUSCRIPT OR ADDITIONAL MATERIALS FOR FURTHER EVALUATION.

- OFFER REPRESENTATION AND DISCUSS CONTRACT TERMS.
- DECLINE REPRESENTATION BUT PROVIDE CONSTRUCTIVE FEEDBACK.
- DELAY RESPONSE DUE TO WORKLOAD OR OTHER FACTORS.

AUTHORS SHOULD CONTINUE SUBMITTING TO MULTIPLE AGENTS SIMULTANEOUSLY, UNLESS AN AGENT SPECIFICALLY REQUESTS EXCLUSIVITY. THIS APPROACH ENHANCES THE CHANCES OF FINDING THE RIGHT PARTNERSHIP FOR PUBLICATION SUCCESS.

FREQUENTLY ASKED QUESTIONS

WHICH CHILDREN'S BOOK AGENTS ARE ACTIVELY ACCEPTING SUBMISSIONS IN 2023?

IN 2023, SEVERAL CHILDREN'S BOOK AGENTS SUCH AS ANDREA BROWN LITERARY AGENCY, WRITERS HOUSE, AND ERIN MURPHY LITERARY AGENCY ARE ACTIVELY ACCEPTING SUBMISSIONS. IT'S IMPORTANT TO CHECK THEIR INDIVIDUAL WEBSITES FOR SPECIFIC SUBMISSION GUIDELINES AND OPEN PERIODS.

WHAT ARE THE COMMON SUBMISSION REQUIREMENTS FOR CHILDREN'S BOOK AGENTS IN 2023?

MOST CHILDREN'S BOOK AGENTS IN 2023 REQUIRE A QUERY LETTER, A SYNOPSIS OF THE BOOK, AND THE FIRST 10-50 PAGES OR FULL MANUSCRIPT, DEPENDING ON THE AGENT. SOME MAY ALSO ASK FOR A MARKETING PLAN OR AUTHOR BIO. ALWAYS REFER TO THE AGENT'S SUBMISSION GUIDELINES FOR PRECISE INSTRUCTIONS.

ARE UNSOLICITED SUBMISSIONS ACCEPTED BY CHILDREN'S BOOK AGENTS IN 2023?

MANY CHILDREN'S BOOK AGENTS IN 2023 ACCEPT UNSOLICITED SUBMISSIONS, MEANING AUTHORS CAN SUBMIT WITHOUT A PRIOR REFERRAL. HOWEVER, SOME PREFER REFERRALS OR SUBMISSIONS THROUGH ESTABLISHED CONNECTIONS. IT'S BEST TO VERIFY THIS ON EACH AGENT'S WEBSITE BEFORE SUBMITTING.

HOW CAN AUTHORS FIND UPDATED LISTS OF CHILDREN'S BOOK AGENTS ACCEPTING SUBMISSIONS IN 2023?
