Steps to Conduct a Lookup

1. ACCESS THE SAN DIEGO BUSINESS LICENSE SEARCH PORTAL OR CONTACT THE LICENSING OFFICE.
2. ENTER RELEVANT SEARCH CRITERIA SUCH AS BUSINESS NAME, OWNER NAME, OR LICENSE NUMBER.
3. REVIEW THE SEARCH RESULTS, NOTING LICENSE STATUS AND EXPIRATION.
4. REQUEST ADDITIONAL DOCUMENTATION OR VERIFICATION IF NECESSARY.

Types of Business Licenses in San Diego
