

# CSUF TITLE IX TRAINING ANSWERS

## OVERVIEW OF CSUF TITLE IX TRAINING

THE CSUF TITLE IX TRAINING IS DESIGNED TO EDUCATE THE UNIVERSITY COMMUNITY ABOUT THE LEGAL REQUIREMENTS AND INSTITUTIONAL POLICIES SURROUNDING SEX DISCRIMINATION, SEXUAL HARASSMENT, AND SEXUAL VIOLENCE. TITLE IX IS A FEDERAL CIVIL RIGHTS LAW THAT PROHIBITS DISCRIMINATION ON THE BASIS OF SEX IN ANY EDUCATION PROGRAM OR ACTIVITY RECEIVING FEDERAL FINANCIAL ASSISTANCE. CSUF'S TRAINING ENSURES THAT ALL MEMBERS OF THE CAMPUS UNDERSTAND THEIR RIGHTS AND RESPONSIBILITIES UNDER THIS LAW.

COMPLETION OF THE TITLE IX TRAINING IS MANDATORY FOR ALL STUDENTS, FACULTY, AND STAFF. IT IS TYPICALLY OFFERED THROUGH AN ONLINE PLATFORM THAT ALLOWS PARTICIPANTS TO LEARN AT THEIR OWN PACE WHILE ENSURING COMPREHENSION THROUGH QUIZZES AND ASSESSMENTS. THE TRAINING IS UPDATED REGULARLY TO REFLECT CHANGES IN FEDERAL REGULATIONS AND INSTITUTIONAL POLICY ADJUSTMENTS.

## PURPOSE AND IMPORTANCE

THE PRIMARY PURPOSE OF CSUF TITLE IX TRAINING IS TO PREVENT INCIDENTS OF SEXUAL HARASSMENT AND DISCRIMINATION BY PROMOTING AWARENESS AND UNDERSTANDING. THE TRAINING EQUIPS INDIVIDUALS WITH THE KNOWLEDGE TO IDENTIFY INAPPROPRIATE CONDUCT AND UNDERSTAND THE PROCEDURES FOR REPORTING AND ADDRESSING COMPLAINTS. THIS PROACTIVE APPROACH SUPPORTS A CAMPUS CULTURE THAT VALUES RESPECT, EQUITY, AND SAFETY.

## WHO MUST COMPLETE THE TRAINING?

ALL STUDENTS ENROLLING AT CSUF, NEW HIRES, AND EXISTING STAFF AND FACULTY MEMBERS ARE REQUIRED TO COMPLETE TITLE IX TRAINING. THE UNIVERSITY OFTEN SETS DEADLINES FOR COMPLETION TO ENSURE COMPLIANCE AND MAINTAIN A SAFE EDUCATIONAL ENVIRONMENT. ADDITIONALLY, SOME DEPARTMENTS MAY REQUIRE REFRESHER TRAINING ANNUALLY OR BIANNUALLY.

# KEY TOPICS COVERED IN THE TRAINING

CSUF TITLE IX TRAINING COVERS A COMPREHENSIVE RANGE OF TOPICS TO ENSURE PARTICIPANTS FULLY UNDERSTAND THE LEGAL FRAMEWORK AND PRACTICAL IMPLICATIONS OF TITLE IX. THE TRAINING FOCUSES ON CRITICAL AREAS SUCH AS DEFINITIONS OF PROHIBITED CONDUCT, REPORTING MECHANISMS, AND THE RIGHTS OF BOTH COMPLAINANTS AND RESPONDENTS.

## DEFINITIONS AND EXAMPLES OF SEXUAL MISCONDUCT

THE TRAINING CLEARLY DEFINES SEXUAL HARASSMENT, SEXUAL ASSAULT, DATING VIOLENCE, DOMESTIC VIOLENCE, STALKING, AND RETALIATION. USING REAL-LIFE SCENARIOS, THE COURSE ILLUSTRATES WHAT CONSTITUTES MISCONDUCT UNDER TITLE IX, HELPING INDIVIDUALS RECOGNIZE BEHAVIORS THAT VIOLATE UNIVERSITY POLICIES.

## REPORTING PROCEDURES

PARTICIPANTS LEARN ABOUT THE VARIOUS WAYS TO REPORT INCIDENTS OF SEXUAL MISCONDUCT AT CSUF. THE TRAINING EXPLAINS CONFIDENTIAL RESOURCES, FORMAL REPORTING CHANNELS, AND THE ROLE OF THE TITLE IX COORDINATOR. EMPHASIS IS PLACED ON TIMELY REPORTING AND THE PROTECTIONS AVAILABLE TO THOSE WHO REPORT.

## INVESTIGATION AND RESOLUTION PROCESS

THE COURSE OUTLINES THE STEPS CSUF TAKES ONCE A COMPLAINT IS FILED, INCLUDING INVESTIGATION PROTOCOLS, INTERIM MEASURES, AND POTENTIAL OUTCOMES. IT ALSO DESCRIBES THE RIGHTS OF BOTH THE COMPLAINANT AND THE ACCUSED DURING THE PROCESS TO ENSURE FAIRNESS AND DUE PROCESS.

## COMMON QUESTIONS AND ANSWERS ABOUT CSUF TITLE IX TRAINING

MANY PARTICIPANTS HAVE QUESTIONS REGARDING THE CONTENT AND REQUIREMENTS OF THE CSUF TITLE IX TRAINING. BELOW ARE SOME FREQUENTLY ASKED QUESTIONS ALONG WITH DETAILED ANSWERS TO CLARIFY COMMON CONCERNS.

### 1. WHAT IS THE DEADLINE TO COMPLETE THE TITLE IX TRAINING AT CSUF?

THE UNIVERSITY TYPICALLY REQUIRES COMPLETION WITHIN THE FIRST FEW WEEKS OF ENROLLMENT OR EMPLOYMENT. SPECIFIC DEADLINES ARE COMMUNICATED VIA EMAIL AND UNIVERSITY PORTALS.

### 2. IS THE TITLE IX TRAINING CONFIDENTIAL?

THE TRAINING ITSELF IS CONFIDENTIAL AND COMPLETED INDIVIDUALLY. HOWEVER, INFORMATION DISCLOSED DURING ACTUAL INCIDENT REPORTING MAY BE SUBJECT TO UNIVERSITY POLICIES ON CONFIDENTIALITY.

### 3. WHAT HAPPENS IF I DON'T COMPLETE THE TRAINING ON TIME?

FAILURE TO COMPLETE THE TRAINING MAY RESULT IN HOLDS ON REGISTRATION, PAYROLL, OR OTHER ADMINISTRATIVE ACTIONS UNTIL THE REQUIREMENT IS FULFILLED.

### 4. CAN I RETAKE THE TRAINING IF I FAIL THE QUIZ?

YES, PARTICIPANTS CAN RETAKE ASSESSMENTS TO ENSURE FULL UNDERSTANDING OF THE MATERIAL.

### 5. WHO DO I CONTACT IF I HAVE QUESTIONS ABOUT TITLE IX AT CSUF?

THE TITLE IX COORDINATOR'S OFFICE IS THE PRIMARY CONTACT FOR QUESTIONS AND CONCERNS RELATED TO CSUF TITLE IX POLICIES AND TRAINING.

## RESPONSIBILITIES OF MANDATORY REPORTERS

AT CSUF, CERTAIN EMPLOYEES ARE DESIGNATED AS MANDATORY REPORTERS UNDER TITLE IX REGULATIONS. THESE INDIVIDUALS HAVE A LEGAL OBLIGATION TO REPORT ANY INCIDENTS OF SEXUAL HARASSMENT OR MISCONDUCT THEY BECOME AWARE OF DURING THEIR PROFESSIONAL DUTIES.

## IDENTIFYING MANDATORY REPORTERS

MANDATORY REPORTERS TYPICALLY INCLUDE FACULTY MEMBERS, ADMINISTRATORS, COACHES, AND CERTAIN STAFF WHO INTERACT REGULARLY WITH STUDENTS. THE TRAINING SPECIFIES WHO THESE REPORTERS ARE AND THE SCOPE OF THEIR RESPONSIBILITIES.

## REPORTING OBLIGATIONS AND PROCEDURES

MANDATORY REPORTERS MUST PROMPTLY REPORT INCIDENTS TO THE TITLE IX OFFICE, PROVIDING ALL RELEVANT INFORMATION. FAILURE TO REPORT CAN RESULT IN DISCIPLINARY ACTION. THE TRAINING PROVIDES CLEAR GUIDELINES ON HOW AND WHEN TO FILE THESE REPORTS WHILE RESPECTING THE PRIVACY OF INVOLVED PARTIES.

- RECOGNIZE INCIDENTS OF SEXUAL MISCONDUCT
- REPORT INCIDENTS PROMPTLY TO THE TITLE IX COORDINATOR
- MAINTAIN CONFIDENTIALITY AS PERMITTED BY LAW
- SUPPORT AFFECTED INDIVIDUALS BY PROVIDING RESOURCE INFORMATION

## RESOURCES AND SUPPORT SERVICES AT CSUF

CSUF OFFERS A VARIETY OF RESOURCES TO SUPPORT INDIVIDUALS AFFECTED BY SEXUAL MISCONDUCT OR SEEKING INFORMATION ABOUT TITLE IX POLICIES. THESE SERVICES ARE INTEGRAL TO THE UNIVERSITY'S COMMITMENT TO A SAFE AND EQUITABLE CAMPUS ENVIRONMENT.

## CONFIDENTIAL SUPPORT SERVICES

CONFIDENTIAL RESOURCES INCLUDE COUNSELING CENTERS, HEALTH SERVICES, AND ADVOCACY OFFICES WHERE INDIVIDUALS CAN SEEK HELP WITHOUT TRIGGERING A FORMAL INVESTIGATION UNLESS THEY CHOOSE TO REPORT.

## TITLE IX COORDINATOR AND OFFICE

THE TITLE IX OFFICE SERVES AS THE CENTRAL HUB FOR REPORTING, INVESTIGATION, AND RESOLUTION OF COMPLAINTS. THE COORDINATOR ENSURES COMPLIANCE WITH FEDERAL LAWS AND UNIVERSITY POLICIES AND PROVIDES EDUCATION AND

## EDUCATIONAL MATERIALS AND WORKSHOPS

CSUF REGULARLY OFFERS WORKSHOPS AND DISTRIBUTES EDUCATIONAL MATERIALS TO RAISE AWARENESS ABOUT TITLE IX. THESE INITIATIVES AIM TO BUILD A CAMPUS CULTURE THAT PREVENTS SEXUAL MISCONDUCT AND SUPPORTS SURVIVORS.

## FREQUENTLY ASKED QUESTIONS

### WHAT IS CSUF TITLE IX TRAINING?

CSUF TITLE IX TRAINING IS AN EDUCATIONAL PROGRAM DESIGNED TO INFORM STUDENTS, FACULTY, AND STAFF AT CALIFORNIA STATE UNIVERSITY, FULLERTON ABOUT THEIR RIGHTS AND RESPONSIBILITIES UNDER TITLE IX, WHICH PROHIBITS SEX DISCRIMINATION IN EDUCATION.

### WHO IS REQUIRED TO COMPLETE THE CSUF TITLE IX TRAINING?

ALL CSUF STUDENTS, FACULTY, AND STAFF ARE GENERALLY REQUIRED TO COMPLETE TITLE IX TRAINING TO ENSURE AWARENESS AND COMPLIANCE WITH UNIVERSITY POLICIES REGARDING SEXUAL HARASSMENT AND DISCRIMINATION.

### WHERE CAN I FIND THE OFFICIAL CSUF TITLE IX TRAINING ANSWERS?

OFFICIAL ANSWERS FOR CSUF TITLE IX TRAINING ARE PROVIDED WITHIN THE TRAINING MODULES THEMSELVES, AND SHARING OR SEEKING DIRECT ANSWER KEYS IS DISCOURAGED TO MAINTAIN THE INTEGRITY OF THE TRAINING.

### HOW CAN I PREPARE FOR THE CSUF TITLE IX TRAINING QUIZ?

TO PREPARE FOR THE CSUF TITLE IX TRAINING QUIZ, CAREFULLY REVIEW ALL PROVIDED MATERIALS, UNDERSTAND UNIVERSITY POLICIES ON SEXUAL HARASSMENT AND DISCRIMINATION, AND COMPLETE ALL MODULES THOROUGHLY.

### WHAT HAPPENS IF I DO NOT COMPLETE THE CSUF TITLE IX TRAINING ON TIME?

FAILURE TO COMPLETE CSUF TITLE IX TRAINING BY THE DEADLINE MAY RESULT IN HOLDS ON REGISTRATION, ACCESS TO CERTAIN CAMPUS RESOURCES BEING RESTRICTED, OR OTHER ADMINISTRATIVE CONSEQUENCES AS DETERMINED BY THE UNIVERSITY.
