OVERVIEW OF THE DELAWARE EDGE GRANT

THE DELAWARE EDGE GRANT IS A STATE-FUNDED ECONOMIC DEVELOPMENT TOOL AIMED AT ENCOURAGING BUSINESS GROWTH AND INVESTMENT WITHIN DELAWARE. EDGE STANDS FOR "ECONOMIC DEVELOPMENT GRANT EQUITY," REFLECTING THE PROGRAM'S PURPOSE OF PROMOTING EQUITABLE ECONOMIC OPPORTUNITIES ACROSS THE STATE. ESTABLISHED TO HELP BUSINESSES OFFSET COSTS RELATED TO EXPANSION, THE GRANT SUPPORTS A VARIETY OF ACTIVITIES INCLUDING CAPITAL INVESTMENT, JOB CREATION, AND WORKFORCE DEVELOPMENT. BY PROVIDING FINANCIAL ASSISTANCE, THE DELAWARE EDGE GRANT HELPS REDUCE THE FINANCIAL RISK FOR COMPANIES CONSIDERING DELAWARE AS A LOCATION FOR GROWTH. PURPOSE AND OBJECTIVES

FUNDING STRUCTURE

FUNDING UNDER THE DELAWARE EDGE GRANT IS TYPICALLY AWARDED AS A DIRECT CASH GRANT OR REIMBURSEMENT, WHICH CAN BE USED TO OFFSET ELIGIBLE COSTS INCURRED DURING A PROJECT. THE AMOUNT AWARDED VARIES BASED ON THE SIZE AND

ELIGIBILITY REQUIREMENTS

INVESTMENT AND JOB CREATION THRESHOLDS

APPLICANTS MUST GENERALLY COMMIT TO SIGNIFICANT CAPITAL INVESTMENT AND JOB CREATION TO QUALIFY. THE MINIMUM INVESTMENT THRESHOLD VARIES DEPENDING ON THE SIZE OF THE COMPANY AND THE NATURE OF THE PROJECT, BUT TYPICALLY INCLUDES:

- CAPITAL INVESTMENT IN PROPERTY, PLANT, OR EQUIPMENT
- CREATION OF NEW, FULL-TIME PERMANENT JOBS WITHIN A DEFINED TIMEFRAME
- WAGES FOR NEW JOBS THAT MEET OR EXCEED STATE AVERAGE INCOME LEVELS

MEETING OR EXCEEDING THESE THRESHOLDS IS CRITICAL FOR SUCCESSFUL APPLICATION CONSIDERATION.

APPLICATION PROCESS

THE APPLICATION PROCESS FOR THE DELAWARE EDGE GRANT IS STRUCTURED TO EVALUATE THE VIABILITY AND ECONOMIC IMPACT OF PROPOSED PROJECTS THOROUGHLY.
