SPECIAL EVENT VENDOR LICENSE

FOR VENDORS PARTICIPATING IN FAIRS, FESTIVALS, MARKETS, OR OTHER TEMPORARY EVENTS, A SPECIAL EVENT VENDOR LICENSE IS REQUIRED. THIS LICENSE IS TYPICALLY ISSUED FOR SHORT DURATIONS AND ALLOWS VENDORS TO LEGALLY SELL AT DESIGNATED EVENTS.

APPLICATION PROCESS FOR A DETROIT VENDOR LICENSE
