CONTEXT AND SETTING

DESCRIBING THE ENVIRONMENT, TIME, AND CIRCUMSTANCES OF THE INTERACTION IS IMPORTANT TO UNDERSTAND THE DYNAMICS THAT INFLUENCED THE COMMUNICATION. THIS INCLUDES NOTING THE PATIENT'S CONDITION, PRIVACY LEVEL, AND ANY EXTERNAL FACTORS IMPACTING THE EXCHANGE.

ANALYSIS AND REFLECTION

IN THIS PART, THE NURSE EVALUATES THE COMMUNICATION PROCESS, IDENTIFYING STRENGTHS, WEAKNESSES, AND AREAS FOR IMPROVEMENT. THE NURSE MAY DISCUSS THE USE OF THERAPEUTIC COMMUNICATION TECHNIQUES, EMOTIONAL RESPONSES, AND HOW WELL THE PATIENT'S NEEDS WERE ADDRESSED.

PLAN FOR FUTURE INTERACTIONS

BASED ON THE ANALYSIS, THE NURSE OUTLINES STRATEGIES TO ENHANCE FUTURE COMMUNICATION AND PATIENT CARE. THIS PLAN MAY INCLUDE SPECIFIC COMMUNICATION SKILLS TO PRACTICE, EDUCATIONAL NEEDS, OR CHANGES IN APPROACH TO BETTER MEET PATIENT NEEDS.

EXAMPLE OF PROCESS RECORDING NURSING

BELOW IS A DETAILED EXAMPLE OF PROCESS RECORDING NURSING THAT ILLUSTRATES HOW TO DOCUMENT AND ANALYZE NURSE-PATIENT INTERACTIONS EFFECTIVELY.

CONTEXT

THE INTERACTION TOOK PLACE IN A HOSPITAL ROOM DURING A ROUTINE MORNING ASSESSMENT OF A 65-YEAR-OLD MALE PATIENT RECOVERING FROM SURGERY. THE PATIENT APPEARED ANXIOUS AND EXPRESSED CONCERNS ABOUT PAIN MANAGEMENT.

VERBATIM ACCOUNT

- **NURSE:** "GOOD MORNING, MR. SMITH. HOW ARE YOU FEELING TODAY?"
- **PATIENT:** "I'M REALLY WORRIED ABOUT MY PAIN. THE MEDICATION DOESN'T SEEM TO HELP MUCH."
- **NURSE:** "I UNDERSTAND YOUR CONCERN. CAN YOU TELL ME MORE ABOUT THE PAIN YOU ARE EXPERIENCING?"
- **PATIENT:** "IT'S SHARP AND CONSTANT, ESPECIALLY WHEN I MOVE."
- **NURSE:** "HAVE YOU NOTICED IF THE PAIN WORSENS AT ANY PARTICULAR TIME OR ACTIVITY?"
- **PATIENT:** "YES, IT GETS WORSE WHEN I TRY TO GET OUT OF BED."
- **NURSE:** "THANK YOU FOR SHARING THAT. I WILL INFORM THE DOCTOR SO WE CAN ADJUST YOUR PAIN MANAGEMENT PLAN

ACCORDINGLY.”

- **PATIENT:** “I APPRECIATE THAT. IT’S BEEN HARD TO REST WITH THIS PAIN.”

ANALYSIS

THE NURSE USED OPEN-ENDED QUESTIONS TO ENCOURAGE THE PATIENT TO DESCRIBE HIS PAIN IN DETAIL, WHICH IS A KEY THERAPEUTIC COMMUNICATION SKILL. REFLECTIVE LISTENING WAS DEMONSTRATED BY ACKNOWLEDGING THE PATIENT’S CONCERNS AND EXPRESSING EMPATHY. HOWEVER, THE NURSE COULD HAVE FURTHER EXPLORED THE PATIENT’S EMOTIONAL STATE AND PROVIDED REASSURANCE TO REDUCE ANXIETY. THE NURSE APPROPRIATELY PLANNED TO COMMUNICATE WITH THE HEALTHCARE TEAM TO ADDRESS THE PAIN ISSUE, SHOWING GOOD CLINICAL JUDGMENT.

PLAN

FUTURE INTERACTIONS WILL INCLUDE MORE EMOTIONAL SUPPORT BY VALIDATING THE PATIENT’S FEELINGS AND PROVIDING REASSURANCE. THE NURSE SHOULD ALSO FOLLOW UP AFTER THE PHYSICIAN’S RESPONSE TO ENSURE THE PAIN MANAGEMENT PLAN IS EFFECTIVE AND THE PATIENT FEELS SUPPORTED. PRACTICING ACTIVE LISTENING AND EMPATHY WILL REMAIN A PRIORITY IN SUBSEQUENT ENCOUNTERS.

BENEFITS OF PROCESS RECORDING IN NURSING PRACTICE
