OVERVIEW OF FINANCIAL AID AT STEVENSON UNIVERSITY

STEVENSON UNIVERSITY OFFERS A ROBUST FINANCIAL AID PROGRAM AIMED AT SUPPORTING STUDENTS IN MEETING THE COSTS ASSOCIATED WITH HIGHER EDUCATION. THE UNIVERSITY'S FINANCIAL AID OFFICE WORKS CLOSELY WITH STUDENTS TO PROVIDE A RANGE OF FUNDING OPTIONS, COMBINING FEDERAL, STATE, AND INSTITUTIONAL RESOURCES. FINANCIAL AID AT STEVENSON UNIVERSITY IS DESIGNED TO REDUCE THE FINANCIAL BURDEN ON STUDENTS AND THEIR FAMILIES BY PROVIDING ASSISTANCE BASED ON NEED, MERIT, OR A COMBINATION OF BOTH. THE GOAL IS TO ENSURE THAT QUALIFIED STUDENTS HAVE ACCESS TO EDUCATIONAL OPPORTUNITIES REGARDLESS OF THEIR FINANCIAL BACKGROUND. TYPES OF FINANCIAL AID AVAILABLE

SCHOLARSHIPS

GRANTS

GRANTS ARE TYPICALLY NEED-BASED FINANCIAL AID THAT ALSO DOES NOT REQUIRE REPAYMENT. THEY ARE AWARDED TO STUDENTS WHO DEMONSTRATE FINANCIAL NEED THROUGH THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) OR OTHER FINANCIAL DOCUMENTATION.

LOANS

LOANS PROVIDE STUDENTS WITH BORROWED FUNDS THAT MUST BE REPAYED WITH INTEREST AFTER GRADUATION OR WHEN THE STUDENT LEAVES SCHOOL. STEVENSON UNIVERSITY FACILITATES ACCESS TO FEDERAL AND PRIVATE LOAN PROGRAMS TO HELP STUDENTS BRIDGE ANY REMAINING FINANCIAL GAPS.

WORK-STUDY PROGRAMS

WORK-STUDY PROGRAMS ALLOW ELIGIBLE STUDENTS TO EARN MONEY THROUGH PART-TIME EMPLOYMENT WHILE ENROLLED IN CLASSES. THESE POSITIONS OFTEN RELATE TO THE STUDENT'S FIELD OF STUDY OR CAMPUS SERVICES, PROVIDING VALUABLE WORK EXPERIENCE ALONGSIDE FINANCIAL SUPPORT.

APPLICATION PROCESS AND REQUIREMENTS

APPLYING FOR FINANCIAL AID AT STEVENSON UNIVERSITY INVOLVES SEVERAL CRITICAL STEPS TO ENSURE ELIGIBILITY AND MAXIMIZE AID AWARDS. SUPPORTING DOCUMENTATION

IN SOME CASES, STUDENTS MAY BE REQUIRED TO PROVIDE ADDITIONAL DOCUMENTATION SUCH AS TAX RETURNS, VERIFICATION WORKSHEETS, OR PROOF OF RESIDENCY. THE UNIVERSITY'S FINANCIAL AID OFFICE WILL COMMUNICATE ANY REQUESTS FOR SUPPLEMENTAL MATERIALS AFTER FAFSA SUBMISSION.

DEADLINES AND TIMELINES

TIMELY SUBMISSION OF THE FAFSA AND ANY ADDITIONAL DOCUMENTS IS CRUCIAL FOR RECEIVING FINANCIAL AID. STEVENSON UNIVERSITY ENCOURAGES STUDENTS TO APPLY AS EARLY AS POSSIBLE, AS SOME AID FUNDS ARE LIMITED AND AWARDED ON A FIRST-COME, FIRST-SERVED BASIS.

ACADEMIC SCHOLARSHIPS

NEED-BASED GRANTS

LOANS AND REPAYMENT OPTIONS

LOANS REPRESENT AN IMPORTANT COMPONENT OF FINANCIAL AID AT STEVENSON UNIVERSITY FOR STUDENTS WHO REQUIRE ADDITIONAL FUNDING BEYOND SCHOLARSHIPS AND GRANTS. UNDERSTANDING THE TYPES OF LOANS, THEIR TERMS, AND REPAYMENT OPTIONS IS ESSENTIAL TO RESPONSIBLE BORROWING.

FEDERAL STUDENT LOANS

STEVENSON UNIVERSITY FACILITATES ACCESS TO FEDERAL STUDENT LOANS, INCLUDING DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS. THESE LOANS HAVE FIXED INTEREST RATES AND OFFER FLEXIBLE REPAYMENT PLANS AFTER GRADUATION.

PRIVATE LOANS

PRIVATE LOANS ARE AVAILABLE THROUGH BANKS AND LENDING INSTITUTIONS AND USUALLY REQUIRE A CREDIT CHECK AND CO-SIGNER. THESE LOANS MAY HAVE VARIABLE INTEREST RATES AND LESS FLEXIBLE REPAYMENT OPTIONS COMPARED TO FEDERAL

LOANS.

REPAYMENT PLANS AND LOAN COUNSELING

THE UNIVERSITY PROVIDES RESOURCES AND COUNSELING TO HELP STUDENTS UNDERSTAND LOAN REPAYMENT OPTIONS, DEFERMENT OPPORTUNITIES, AND STRATEGIES TO MANAGE DEBT RESPONSIBLY AFTER LEAVING SCHOOL.

WORK-STUDY AND EMPLOYMENT OPPORTUNITIES

STEVENSON UNIVERSITY'S WORK-STUDY PROGRAM PROVIDES STUDENTS WITH PART-TIME JOB OPPORTUNITIES THAT HELP FINANCE THEIR EDUCATION WHILE GAINING VALUABLE WORK EXPERIENCE. THESE JOBS OFTEN TAKE PLACE ON CAMPUS OR WITH APPROVED COMMUNITY PARTNERS.

ELIGIBILITY FOR WORK-STUDY

STUDENTS MUST DEMONSTRATE FINANCIAL NEED AS DETERMINED BY THE FAFSA TO QUALIFY FOR WORK-STUDY POSITIONS. THE AVAILABILITY OF JOBS DEPENDS ON FUNDING AND DEPARTMENTAL NEEDS.

BENEFITS OF WORK-STUDY EMPLOYMENT

WORK-STUDY JOBS OFFER FLEXIBLE SCHEDULES DESIGNED TO ACCOMMODATE ACADEMIC COMMITMENTS, FOSTERING A BALANCE BETWEEN WORK AND STUDY. THIS PROGRAM NOT ONLY SUPPORTS STUDENTS FINANCIALLY BUT ALSO ENHANCES RESUMES AND PROFESSIONAL SKILLS.

MAINTAINING AND MANAGING FINANCIAL AID

RENEWAL AND REAPPLICATION

MOST FINANCIAL AID AWARDS REQUIRE ANNUAL RENEWAL THROUGH TIMELY FAFSA SUBMISSION AND VERIFICATION PROCESSES. STUDENTS SHOULD ALSO REVIEW THEIR FINANCIAL AID PACKAGES EACH YEAR TO ADJUST FOR CHANGES IN STATUS OR ADDITIONAL FUNDING OPPORTUNITIES.

FINANCIAL AID COUNSELING AND SUPPORT

THE UNIVERSITY'S FINANCIAL AID OFFICE OFFERS COUNSELING SERVICES TO ASSIST STUDENTS WITH BUDGETING, UNDERSTANDING THEIR AID PACKAGES, AND EXPLORING ALTERNATIVE FUNDING OPTIONS IF NECESSARY.
