OVERVIEW OF GENERAL PRESIDENCIES LDS

THESE PRESIDENCIES OPERATE UNDER THE DIRECTION OF THE FIRST PRESIDENCY AND THE QUORUM OF THE TWELVE APOSTLES, ENSURING ALIGNMENT WITH THE CHURCH'S OVERALL MISSION AND DOCTRINE. THE CONCEPT OF GENERAL PRESIDENCIES IS INTEGRAL TO THE CHURCH'S ADMINISTRATIVE FRAMEWORK, ALLOWING FOR SPECIALIZED FOCUS ON VARIOUS GROUPS SUCH AS WOMEN, YOUTH, CHILDREN, AND PRIESTHOOD HOLDERS. BY MAINTAINING GENERAL PRESIDENCIES, THE LDS CHURCH FOSTERS CONSISTENT TEACHING, TRAINING, AND SERVICE OPPORTUNITIES THAT SUPPORT MEMBERS SPIRITUALLY AND SOCIALLY ACROSS THE GLOBE.

MAIN ORGANIZATIONS LED BY GENERAL PRESIDENCIES

WITHIN THE LDS CHURCH, SEVERAL KEY AUXILIARY ORGANIZATIONS ARE GOVERNED BY THEIR RESPECTIVE GENERAL PRESIDENCIES. EACH OF THESE PRESIDENCIES PROVIDES LEADERSHIP AND DIRECTION TAILORED TO THE NEEDS OF THEIR SPECIFIC MEMBERSHIP GROUPS. THE MAIN ORGANIZATIONS LED BY GENERAL PRESIDENCIES INCLUDE:

- **RELIEF SOCIETY:** THE ORGANIZATION FOR ADULT WOMEN, FOCUSED ON SPIRITUAL GROWTH, SERVICE, AND WELFARE.
- **YOUNG WOMEN:** SERVING FEMALE YOUTH AGES 12 TO 18, EMPHASIZING FAITH, PERSONAL DEVELOPMENT, AND PREPARATION FOR ADULTHOOD.
- **PRIMARY:** THE ORGANIZATION FOR CHILDREN UNDER AGE 12, OFFERING RELIGIOUS EDUCATION AND ACTIVITIES.
- **SUNDAY SCHOOL:** RESPONSIBLE FOR GOSPEL INSTRUCTION FOR ALL MEMBERS, COORDINATING CURRICULUM AND TEACHING RESOURCES.

- **YOUNG MEN:** SERVING MALE YOUTH AGES 12 TO 18, WITH AN EMPHASIS ON PRIESTHOOD PREPARATION, SPIRITUAL GROWTH, AND SERVICE.

EACH PRESIDENCY WORKS CLOSELY WITH LOCAL LEADERS AND MEMBERS TO IMPLEMENT PROGRAMS AND INITIATIVES THAT ALIGN WITH THE CHURCH'S GLOBAL VISION.

ROLES AND RESPONSIBILITIES OF THE GENERAL PRESIDENCIES

GENERAL PRESIDENCIES LDS CARRY OUT A VARIETY OF IMPORTANT ROLES AND RESPONSIBILITIES THAT ENSURE THE SMOOTH FUNCTIONING OF THEIR RESPECTIVE ORGANIZATIONS. THEIR DUTIES INCLUDE:

- SETTING PROGRAM OBJECTIVES AND PRIORITIES CONSISTENT WITH CHURCH DOCTRINE AND POLICIES.
- DEVELOPING AND APPROVING INSTRUCTIONAL MATERIALS, LESSON MANUALS, AND CURRICULUM GUIDES.
- PROVIDING TRAINING AND SUPPORT FOR LOCAL LEADERS AND TEACHERS WORLDWIDE.
- OVERSEEING WELFARE, HUMANITARIAN, AND SERVICE PROJECTS WITHIN THEIR ORGANIZATIONS.
- ENCOURAGING MEMBER PARTICIPATION IN RELIGIOUS EDUCATION, SERVICE, AND LEADERSHIP.
- COLLABORATING WITH OTHER CHURCH DEPARTMENTS TO PROMOTE UNIFIED EFFORTS AND RESOURCE SHARING.

THESE RESPONSIBILITIES REQUIRE THE PRESIDENCIES TO BE SPIRITUALLY INSPIRED, ADMINISTRATIVELY CAPABLE, AND GLOBALLY MINDED TO ADDRESS THE DIVERSE NEEDS OF CHURCH MEMBERS.

APPOINTMENT AND TENURE OF GENERAL PRESIDENCIES

THE MEMBERS OF GENERAL PRESIDENCIES LDS ARE CALLED BY THE HIGHEST LEADERS OF THE LDS CHURCH, TYPICALLY THROUGH REVELATION AND PRAYERFUL CONSIDERATION BY THE FIRST PRESIDENCY AND THE QUORUM OF THE TWELVE APOSTLES. THESE APPOINTMENTS ARE CONSIDERED SACRED AND LIFELONG CALLINGS, THOUGH TENURE LENGTH MAY VARY DEPENDING ON CIRCUMSTANCES SUCH AS PERSONAL HEALTH, REASSIGNMENT, OR CHANGES IN LEADERSHIP STRUCTURE. ONCE CALLED, PRESIDENTS AND COUNSELORS RECEIVE SPECIFIC TRAINING AND ORIENTATION TO FULFILL THEIR DUTIES EFFECTIVELY.

THE PROCESS OF APPOINTMENT EMPHASIZES SPIRITUAL QUALIFICATIONS, LEADERSHIP EXPERIENCE, AND A DEMONSTRATED COMMITMENT TO THE CHURCH'S TEACHINGS. GENERAL PRESIDENCIES OFTEN SERVE FOR SEVERAL YEARS, DURING WHICH THEY TRAVEL, TEACH, AND INSPIRE MEMBERS GLOBALLY. THEIR SERVICE IS VOLUNTARY AND UNPAID, REFLECTING THE CHURCH'S EMPHASIS ON CONSECRATED LEADERSHIP AND SERVICE.

HISTORICAL DEVELOPMENT OF GENERAL PRESIDENCIES LDS

THE ESTABLISHMENT AND EVOLUTION OF GENERAL PRESIDENCIES LDS HAVE MIRRORED THE GROWTH AND ORGANIZATIONAL COMPLEXITY OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS. EARLY IN CHURCH HISTORY, AUXILIARY ORGANIZATIONS SUCH AS THE RELIEF SOCIETY WERE ORGANIZED TO PROVIDE FOCUSED MINISTRY AND SERVICE OPPORTUNITIES. OVER TIME, AS THE CHURCH EXPANDED INTERNATIONALLY, THE NEED FOR CENTRALIZED PRESIDENCIES TO OVERSEE THESE ORGANIZATIONS BECAME EVIDENT.

HISTORICAL MILESTONES IN THE DEVELOPMENT OF GENERAL PRESIDENCIES INCLUDE:

1. THE FORMAL ORGANIZATION OF THE RELIEF SOCIETY IN THE 1840S WITH A GENERAL PRESIDENCY.
2. THE CREATION OF THE PRIMARY ORGANIZATION AND ITS GENERAL PRESIDENCY IN THE LATE 19TH CENTURY.

THESE PRESIDENCIES HAVE CONTINUALLY ADAPTED TO MEET CHANGING NEEDS WHILE PRESERVING CORE DOCTRINAL PRINCIPLES.

NOTABLE GENERAL PRESIDENCIES AND THEIR CONTRIBUTIONS

THROUGHOUT LDS CHURCH HISTORY, SEVERAL GENERAL PRESIDENCIES LDS HAVE BEEN PARTICULARLY INFLUENTIAL IN SHAPING THE CHURCH'S AUXILIARY PROGRAMS AND MEMBER EXPERIENCES. NOTABLE PRESIDENCIES ARE OFTEN REMEMBERED FOR THEIR INNOVATION, SPIRITUAL LEADERSHIP, AND HUMANITARIAN EFFORTS. FOR EXAMPLE:

- **YOUNG MEN GENERAL PRESIDENCY:** PRESIDENCIES THAT EMPHASIZED PRIESTHOOD RESPONSIBILITIES AND SERVICE, PREPARING YOUTH FOR FUTURE LEADERSHIP.

THE IMPACT OF THESE PRESIDENCIES EXTENDS BEYOND ADMINISTRATIVE FUNCTIONS; THEY CONTRIBUTE SIGNIFICANTLY TO THE SPIRITUAL GROWTH AND COHESION OF CHURCH MEMBERS GLOBALLY.

HOW ARE MEMBERS OF THE LDS GENERAL PRESIDENCIES SELECTED?

MEMBERS OF LDS GENERAL PRESIDENCIES ARE CALLED BY THE FIRST PRESIDENCY AND THE QUORUM OF THE TWELVE APOSTLES, TYPICALLY BASED ON INSPIRATION AND REVEALED GUIDANCE, AND ARE SUSTAINED BY CHURCH MEMBERS.

WHAT IS THE ROLE OF THE RELIEF SOCIETY GENERAL PRESIDENCY?

THE RELIEF SOCIETY GENERAL PRESIDENCY LEADS THE RELIEF SOCIETY ORGANIZATION, WHICH IS THE CHURCH'S WOMEN'S ORGANIZATION, FOCUSING ON SPIRITUAL GROWTH, SERVICE, AND SUPPORT FOR WOMEN WORLDWIDE.

WHO CURRENTLY SERVES IN THE YOUNG WOMEN GENERAL PRESIDENCY?

AS OF 2024, THE YOUNG WOMEN GENERAL PRESIDENCY IS LED BY A PRESIDENT AND TWO COUNSELORS APPOINTED BY CHURCH LEADERSHIP; SPECIFIC NAMES CAN BE FOUND ON THE OFFICIAL LDS CHURCH WEBSITE OR RECENT ANNOUNCEMENTS.

HOW LONG DO GENERAL PRESIDENCIES TYPICALLY SERVE IN THE LDS CHURCH?

GENERAL PRESIDENCIES USUALLY SERVE FOR SEVERAL YEARS, OFTEN UNTIL THEY ARE RELEASED BY CHURCH LEADERSHIP, BUT THERE IS NO FIXED TERM LENGTH.

CAN MEMBERS OF GENERAL PRESIDENCIES BE WOMEN IN THE LDS CHURCH?
