UNDERSTANDING GHC COMPLEMENTARY MEDICINE

CHIROPRACTIC CARE

CHIROPRACTIC CARE FOCUSES ON DIAGNOSING AND TREATING MUSCULOSKELETAL CONDITIONS, PARTICULARLY THOSE INVOLVING THE SPINE, THROUGH MANUAL ADJUSTMENTS. IT IS COMMONLY USED TO ALLEVIATE BACK PAIN, NECK PAIN, AND HEADACHES.

MIND-BODY TECHNIQUES
