THIS UNIFICATION WAS INTENDED TO CREATE PEACE, PROMOTE COOPERATION, AND ESTABLISH A SYSTEM FOR RESOLVING DISPUTES WITHOUT VIOLENCE.

DEMOCRATIC GOVERNANCE

STRUCTURE OF THE HAUDENOSAUNEE CONFEDERACY

THE HAUDENOSAUNEE CONFEDERACY IS A SOPHISTICATED POLITICAL ENTITY STRUCTURED AROUND A COUNCIL OF REPRESENTATIVES FROM EACH OF THE MEMBER NATIONS. THIS STRUCTURE REFLECTS THE PRINCIPLES AND PROCEDURES OUTLINED IN THE GREAT LAW OF PEACE.

MEMBER NATIONS

THE CONFEDERACY ORIGINALLY CONSISTED OF FIVE NATIONS—THE MOHAWK, ONEIDA, ONONDAGA, CAYUGA, AND SENECA—AND LATER EXPANDED TO INCLUDE THE TUSCARORA. EACH NATION RETAINS ITS OWN IDENTITY, LANGUAGE, AND GOVERNANCE, YET THEY ARE UNITED UNDER THE CONFEDERACY FOR MUTUAL BENEFIT AND PROTECTION.

THE COUNCIL OF CHIEFS

THE PRIMARY GOVERNING BODY IS THE GRAND COUNCIL, COMPOSED OF FIFTY SACHEMS APPOINTED BY CLAN MOTHERS FROM EACH NATION. THESE CHIEFS SERVE AS REPRESENTATIVES AND DECISION-MAKERS, DELIBERATING ON MATTERS AFFECTING THE CONFEDERACY AS A WHOLE. THE COUNCIL OPERATES ON CONSENSUS AND COLLECTIVE AGREEMENT, REFLECTING THE DEMOCRATIC NATURE OF THE GREAT LAW.

CLAN SYSTEM

THE CONFEDERACY IS ORGANIZED INTO CLANS, EACH WITH SPECIFIC ROLES AND RESPONSIBILITIES. CLAN MOTHERS HOLD SIGNIFICANT AUTHORITY, INCLUDING THE POWER TO NOMINATE AND DEPOSE CHIEFS, ENSURING THAT LEADERSHIP REMAINS ACCOUNTABLE TO THE PEOPLE.

3. THE GRAND COUNCIL MAKES DECISIONS THROUGH CONSENSUS.
4. DISPUTES ARE RESOLVED THROUGH MEDIATION AND RESTORATIVE JUSTICE.

CULTURAL AND SPIRITUAL SIGNIFICANCE
