OHIO LAWS GOVERNING POLITICAL SIGNS

OHIO HAS SPECIFIC LAWS THAT REGULATE THE PLACEMENT, DISPLAY, AND REMOVAL OF POLITICAL SIGNS. THESE LAWS ARE DESIGNED TO BALANCE FREE SPEECH RIGHTS WITH PROPERTY RIGHTS AND PUBLIC SAFETY CONCERNS. GENERALLY, POLITICAL SIGNS ARE PROTECTED AS A FORM OF POLITICAL EXPRESSION UNDER THE FIRST AMENDMENT; HOWEVER, THEIR PLACEMENT ON PUBLIC OR PRIVATE PROPERTY WITHOUT PERMISSION IS SUBJECT TO REGULATION.

STATEWIDE REGULATIONS

THE OHIO REVISED CODE INCLUDES PROVISIONS THAT PERTAIN TO POLITICAL SIGNAGE, ESPECIALLY AROUND ELECTION TIMES. TAKING OR DAMAGING THESE SIGNS INTENTIONALLY MAY RESULT IN CRIMINAL CHARGES, INCLUDING MISDEMEANOR OR FELONY OFFENSES DEPENDING ON THE VALUE AND CIRCUMSTANCES.

EXCEPTIONS AND PERMISSIONS

THERE ARE EXCEPTIONS TO THE ILLEGALITY OF REMOVAL, SUCH AS WHEN SIGNS ARE PLACED ILLEGALLY ON PRIVATE PROPERTY WITHOUT PERMISSION OR VIOLATE LOCAL ORDINANCES. PROPERTY OWNERS GENERALLY HAVE THE RIGHT TO REMOVE SIGNS FROM THEIR OWN LAND. ADDITIONALLY, PUBLIC OFFICIALS OR LAW ENFORCEMENT MAY REMOVE SIGNS THAT POSE SAFETY RISKS OR VIOLATE LAWS.

PROPERTY RIGHTS AND POLITICAL SIGNAGE

PROPERTY RIGHTS PLAY A SIGNIFICANT ROLE IN THE LEGALITY OF REMOVING POLITICAL SIGNS IN OHIO. BOTH PUBLIC AND PRIVATE PROPERTY LAWS AFFECT WHETHER A SIGN CAN BE LEGALLY REMOVED OR MUST REMAIN UNTOUCHED.

UNAUTHORIZED SIGNS ON PUBLIC LAND MAY BE REMOVED BY GOVERNMENT AUTHORITIES, BUT INDIVIDUALS REMOVING THESE SIGNS RISK LEGAL CONSEQUENCES. PUBLIC RIGHT-OF-WAY RULES OFTEN RESTRICT WHERE POLITICAL SIGNS CAN BE LEGALLY DISPLAYED.

LOCAL ORDINANCES AND VARIATIONS IN OHIO

DOCUMENT ACTIONS

MAINTAIN RECORDS OF ANY COMMUNICATIONS OR ACTIONS TAKEN REGARDING POLITICAL SIGNS TO PROTECT AGAINST POTENTIAL DISPUTES OR CLAIMS.

FREQUENTLY ASKED QUESTIONS

IS IT ILLEGAL TO REMOVE POLITICAL SIGNS IN OHIO?
