THE VIRAL NATURE OF SOCIAL MEDIA CAN AMPLIFY FALSE MESSAGES RAPIDLY BEFORE FACT-CHECKING OCCURS.

FAN-MADE CONTENT AND PARODIES

SOME FAKE MESSAGES STEM FROM FAN-MADE CONTENT INTENDED AS SATIRE OR PARODY. WHILE THESE MAY BE CREATED WITH HUMOROUS INTENTIONS, THEY CAN SOMETIMES BE MISTAKEN FOR GENUINE COMMUNICATIONS, ESPECIALLY WHEN SHARED OUT OF CONTEXT.

MOTIVATIONS FOR CREATING FAKE MESSAGES

UNDERSTANDING WHY FAKE MESSAGES ARE PRODUCED IS ESSENTIAL TO GRASP THEIR IMPACT. COMMON MOTIVATIONS INCLUDE:

1. GENERATING CONTROVERSY TO INCREASE SOCIAL MEDIA ENGAGEMENT OR FOLLOWERS.
2. DAMAGING THE REPUTATION OF JUSTIN ROILAND FOR PERSONAL OR COMPETITIVE REASONS.
