THE HOSPITAL MAY CHARGE A REASONABLE FEE FOR COPYING AND MAILING RECORDS, IN ACCORDANCE WITH CALIFORNIA STATE LAW. PROCESSING TIMES GENERALLY RANGE FROM A FEW DAYS TO TWO WEEKS, DEPENDING ON THE VOLUME OF RECORDS AND REQUEST COMPLEXITY. EXPEDITED PROCESSING MAY BE AVAILABLE IN URGENT CASES.

## SPECIAL CONSIDERATIONS FOR MINORS AND DECEASED PATIENTS

ACCESS TO MEDICAL RECORDS FOR MINORS OR DECEASED PATIENTS IS GOVERNED BY ADDITIONAL LEGAL REQUIREMENTS. PARENTS OR LEGAL GUARDIANS TYPICALLY HAVE ACCESS TO RECORDS FOR MINORS, WHILE ACCESS FOR DECEASED PATIENTS' RECORDS IS PROVIDED TO AUTHORIZED NEXT OF KIN OR LEGAL REPRESENTATIVES UNDER SPECIFIC CONDITIONS.

## PRIVACY AND SECURITY OF MEDICAL RECORDS
