FROM IMMUNIZATIONS AND FAMILY PLANNING TO ENVIRONMENTAL HEALTH AND EMERGENCY PREPAREDNESS, THE MACON COUNTY HEALTH DEPARTMENT OFFERS A WIDE ARRAY OF PROGRAMS TAILORED TO MEET THE DIVERSE NEEDS OF ITS POPULATION. EMPHASIZING ACCESSIBILITY, EDUCATION, AND PREVENTATIVE CARE, THIS DEPARTMENT WORKS CLOSELY WITH STATE AND LOCAL AGENCIES TO ENSURE THE WELL-BEING OF THE COMMUNITY. OVERVIEW OF MACON COUNTY HEALTH DEPARTMENT NC

THE MACON COUNTY HEALTH DEPARTMENT NC OPERATES AS A GOVERNMENT AGENCY FOCUSED ON SAFEGUARDING PUBLIC HEALTH AND ENHANCING THE QUALITY OF LIFE FOR ALL COUNTY RESIDENTS. IT FUNCTIONS UNDER THE GUIDELINES SET BY THE NORTH CAROLINA DEPARTMENT OF HEALTH AND HUMAN SERVICES AND COLLABORATES WITH LOCAL ORGANIZATIONS TO ADDRESS COMMUNITY HEALTH CHALLENGES EFFECTIVELY. THE DEPARTMENT'S MISSION CENTERS ON PROMOTING HEALTH EQUITY, PREVENTING ILLNESS, AND ENSURING ACCESS TO HEALTHCARE RESOURCES.

MISSION AND VISION

THE MISSION OF THE MACON COUNTY HEALTH DEPARTMENT NC IS TO PROTECT AND IMPROVE THE HEALTH OF THE COMMUNITY THROUGH EDUCATION, PREVENTION, AND PROVISION OF HIGH-QUALITY HEALTH SERVICES. WITH A VISION TO CREATE A HEALTHY ENVIRONMENT WHERE INDIVIDUALS AND FAMILIES THRIVE, THE DEPARTMENT PRIORITIZES EQUITABLE CARE AND COMMUNITY ENGAGEMENT.

ORGANIZATIONAL STRUCTURE

THE HEALTH DEPARTMENT IS STAFFED BY A MULTIDISCIPLINARY TEAM, INCLUDING PUBLIC HEALTH NURSES, ENVIRONMENTAL HEALTH SPECIALISTS, HEALTH EDUCATORS, AND ADMINISTRATIVE PERSONNEL. THIS TEAM WORKS COLLABORATIVELY TO DELIVER A WIDE RANGE OF SERVICES AND ENSURE COMPLIANCE WITH STATE AND FEDERAL HEALTH REGULATIONS.

SERVICES PROVIDED BY THE HEALTH DEPARTMENT

THE MACON COUNTY HEALTH DEPARTMENT NC OFFERS AN EXTENSIVE PORTFOLIO OF HEALTHCARE SERVICES DESIGNED TO ADDRESS THE NEEDS OF VARIOUS POPULATION GROUPS. THESE SERVICES FOCUS ON PREVENTION, DIAGNOSIS, TREATMENT, AND

EDUCATION RELATED TO PUBLIC HEALTH CONCERNS.

CLINICAL SERVICES

CLINICAL SERVICES AT THE DEPARTMENT INCLUDE IMMUNIZATIONS, TUBERCULOSIS TESTING AND TREATMENT, SEXUALLY TRANSMITTED INFECTION (STI) SCREENING AND COUNSELING, FAMILY PLANNING, AND MATERNAL AND CHILD HEALTH SERVICES. THESE OFFERINGS ARE ESSENTIAL FOR REDUCING THE SPREAD OF COMMUNICABLE DISEASES AND SUPPORTING HEALTHY PREGNANCIES AND CHILD DEVELOPMENT.

HEALTH SCREENINGS AND IMMUNIZATIONS

REGULAR HEALTH SCREENINGS AND VACCINATIONS ARE PROVIDED TO PREVENT OUTBREAKS AND PROTECT VULNERABLE POPULATIONS. THE DEPARTMENT OFFERS FLU SHOTS, COVID-19 VACCINES, CHILDHOOD IMMUNIZATIONS, AND ADULT VACCINES FOLLOWING THE RECOMMENDED IMMUNIZATION SCHEDULES.

CHRONIC DISEASE MANAGEMENT

PROGRAMS AIMED AT CONTROLLING CHRONIC DISEASES SUCH AS DIABETES, HYPERTENSION, AND ASTHMA ARE AVAILABLE TO HELP RESIDENTS MANAGE THEIR CONDITIONS EFFECTIVELY. THESE INCLUDE EDUCATION ON LIFESTYLE MODIFICATIONS, MEDICATION ADHERENCE, AND ROUTINE MONITORING.

COMMUNITY HEALTH PROGRAMS AND INITIATIVES

IN ADDITION TO DIRECT CLINICAL SERVICES, THE MACON COUNTY HEALTH DEPARTMENT NC ENGAGES IN SEVERAL COMMUNITY-BASED INITIATIVES DESIGNED TO ENHANCE PUBLIC HEALTH AWARENESS AND FOSTER HEALTHIER LIFESTYLES THROUGHOUT THE COUNTY.

HEALTH EDUCATION AND OUTREACH

THE DEPARTMENT CONDUCTS WORKSHOPS, SEMINARS, AND PUBLIC CAMPAIGNS ON TOPICS INCLUDING NUTRITION, SUBSTANCE ABUSE PREVENTION, MENTAL HEALTH AWARENESS, AND TOBACCO CESSATION. THESE EFFORTS ARE AIMED AT EMPOWERING INDIVIDUALS WITH KNOWLEDGE TO MAKE INFORMED HEALTH DECISIONS.

MATERNAL AND CHILD HEALTH PROGRAMS

SPECIALIZED PROGRAMS SUPPORT PREGNANT WOMEN, INFANTS, AND YOUNG CHILDREN BY PROVIDING PRENATAL CARE EDUCATION, BREASTFEEDING SUPPORT, DEVELOPMENTAL SCREENINGS, AND ACCESS TO NUTRITIONAL RESOURCES SUCH AS THE WOMEN, INFANTS, AND CHILDREN (WIC) PROGRAM.

EMERGENCY PREPAREDNESS AND RESPONSE

THE DEPARTMENT ACTIVELY PARTICIPATES IN EMERGENCY PLANNING AND RESPONSE ACTIVITIES TO PROTECT THE COMMUNITY DURING PUBLIC HEALTH CRISES, NATURAL DISASTERS, OR DISEASE OUTBREAKS. THIS INCLUDES VACCINATION DRIVES, INFORMATION DISSEMINATION, AND COORDINATION WITH REGIONAL EMERGENCY SERVICES.

ENVIRONMENTAL HEALTH AND SAFETY

ENVIRONMENTAL HEALTH IS A CORE COMPONENT OF THE MACON COUNTY HEALTH DEPARTMENT NC'S RESPONSIBILITIES, FOCUSING ON PROTECTING RESIDENTS FROM ENVIRONMENTAL HAZARDS AND ENSURING COMPLIANCE WITH HEALTH AND SAFETY REGULATIONS.

FOOD AND WATER SAFETY

THE DEPARTMENT CONDUCTS ROUTINE INSPECTIONS OF RESTAURANTS, FOOD SERVICE ESTABLISHMENTS, AND PUBLIC WATER SYSTEMS TO ENSURE THEY MEET HEALTH CODES AND REGULATIONS. THESE INSPECTIONS HELP PREVENT FOODBORNE ILLNESSES AND ENSURE SAFE DRINKING WATER.

WASTE MANAGEMENT AND VECTOR CONTROL

PROPER MANAGEMENT OF SOLID AND HAZARDOUS WASTE IS OVERSEEN BY THE DEPARTMENT TO MINIMIZE ENVIRONMENTAL CONTAMINATION. ADDITIONALLY, VECTOR CONTROL PROGRAMS ADDRESS THE REDUCTION OF DISEASE-CARRYING INSECTS AND RODENTS, CRUCIAL FOR PREVENTING VECTOR-BORNE DISEASES.

HOUSING AND SANITATION INSPECTIONS

HEALTH INSPECTORS ASSESS HOUSING CONDITIONS TO IDENTIFY AND MITIGATE HEALTH RISKS SUCH AS MOLD, PEST INFESTATIONS, AND INADEQUATE SANITATION FACILITIES. THESE INSPECTIONS CONTRIBUTE TO SAFER LIVING ENVIRONMENTS FOR RESIDENTS.

HOW TO ACCESS SERVICES AND CONTACT INFORMATION

RESIDENTS OF MACON COUNTY CAN ACCESS HEALTH DEPARTMENT SERVICES THROUGH MULTIPLE CHANNELS, ENSURING CONVENIENCE AND TIMELY CARE. THE DEPARTMENT MAINTAINS ACCESSIBLE OFFICE LOCATIONS AND OFFERS INFORMATION ON ELIGIBILITY, APPOINTMENT SCHEDULING, AND PROGRAM ENROLLMENT.

APPOINTMENT SCHEDULING

APPOINTMENTS FOR CLINICAL SERVICES AND HEALTH PROGRAMS CAN TYPICALLY BE SCHEDULED BY PHONE OR IN PERSON. WALK-IN SERVICES MAY BE AVAILABLE FOR CERTAIN IMMUNIZATIONS AND SCREENINGS, DEPENDING ON DEMAND AND STAFFING.

LOCATION AND OFFICE HOURS

THE MACON COUNTY HEALTH DEPARTMENT NC IS LOCATED CENTRALLY WITHIN THE COUNTY TO FACILITATE EASY ACCESS. OFFICE HOURS ARE DESIGNED TO ACCOMMODATE WORKING INDIVIDUALS AND FAMILIES, WITH SOME SERVICES AVAILABLE DURING EXTENDED HOURS OR BY SPECIAL ARRANGEMENT.

CONTACT METHODS

RESIDENTS MAY CONTACT THE DEPARTMENT VIA TELEPHONE, EMAIL, OR THROUGH COMMUNITY OUTREACH EVENTS. THE HEALTH DEPARTMENT ALSO PROVIDES INFORMATIONAL MATERIALS AND RESOURCES TO ASSIST THE PUBLIC IN NAVIGATING AVAILABLE SERVICES.

THE MACON COUNTY HEALTH DEPARTMENT TYPICALLY OPERATES MONDAY THROUGH FRIDAY FROM 8:00 AM TO 5:00 PM, BUT HOURS MAY VARY, SO IT'S BEST TO CONFIRM BY CALLING OR VISITING THEIR WEBSITE.

CAN I GET WIC SERVICES AT THE MACON COUNTY HEALTH DEPARTMENT?

YES, THE MACON COUNTY HEALTH DEPARTMENT OFFERS THE WOMEN, INFANTS, AND CHILDREN (WIC) NUTRITION PROGRAM TO ELIGIBLE RESIDENTS.

HOW DOES THE MACON COUNTY HEALTH DEPARTMENT HANDLE ENVIRONMENTAL HEALTH CONCERNS?

THE DEPARTMENT PROVIDES ENVIRONMENTAL HEALTH SERVICES SUCH AS RESTAURANT INSPECTIONS, SEPTIC SYSTEM PERMITS, AND WATER QUALITY TESTING TO ENSURE COMMUNITY HEALTH AND SAFETY.

ARE THERE ANY PROGRAMS FOR MATERNAL AND CHILD HEALTH AT THE MACON COUNTY HEALTH DEPARTMENT?

YES, THE MACON COUNTY HEALTH DEPARTMENT OFFERS MATERNAL AND CHILD HEALTH PROGRAMS INCLUDING PRENATAL CARE SUPPORT, CHILD IMMUNIZATIONS, AND HEALTH EDUCATION.
