REQUIREMENTS FOR OBTAINING A MARYLAND PSYCHOLOGY LICENSE

THE STATE OF MARYLAND SETS SPECIFIC EDUCATIONAL AND PROFESSIONAL PREREQUISITES THAT MUST BE FULFILLED TO OBTAIN A VALID PSYCHOLOGY LICENSE. THESE REQUIREMENTS ENSURE THAT LICENSED PSYCHOLOGISTS POSSESS THE NECESSARY KNOWLEDGE AND SKILLS TO PROVIDE COMPETENT MENTAL HEALTH SERVICES.

EDUCATIONAL QUALIFICATIONS

APPLICANTS MUST HOLD A DOCTORAL DEGREE IN PSYCHOLOGY FROM AN ACCREDITED INSTITUTION. THE DEGREE SHOULD BE IN CLINICAL, COUNSELING, EDUCATIONAL, OR ANOTHER RECOGNIZED PSYCHOLOGY SPECIALTY. THE PROGRAM MUST MEET THE CRITERIA SET BY THE MARYLAND BOARD OF EXAMINERS OF PSYCHOLOGISTS, INCLUDING A MINIMUM NUMBER OF CREDIT HOURS AND SUPERVISED TRAINING.

SUPERVISED EXPERIENCE

A CRITICAL COMPONENT FOR LICENSURE IS COMPLETING SUPERVISED PROFESSIONAL EXPERIENCE. MARYLAND REQUIRES APPLICANTS TO COMPLETE A MINIMUM OF 3,500 HOURS OF SUPERVISED WORK, INCLUDING AT LEAST 1,750 HOURS POST-DOCTORAL. THIS SUPERVISED EXPERIENCE MUST BE DOCUMENTED AND VERIFIED BY QUALIFIED SUPERVISORS.

CHARACTER AND BACKGROUND CHECKS

APPLICANTS MUST SUBMIT TO CRIMINAL BACKGROUND CHECKS AND PROVIDE EVIDENCE OF GOOD MORAL CHARACTER. THE MARYLAND BOARD EVALUATES APPLICANTS' HISTORIES TO ENSURE THERE ARE NO FACTORS THAT WOULD COMPROMISE PUBLIC SAFETY OR PROFESSIONAL INTEGRITY.

APPLICATION PROCESS AND EXAMINATION

UNDERSTANDING THE APPLICATION AND EXAMINATION STEPS IS VITAL FOR A SMOOTH LICENSURE PROCESS. THE MARYLAND PSYCHOLOGY LICENSE APPLICATION INVOLVES SEVERAL STAGES, INCLUDING SUBMISSION OF DOCUMENTATION AND SUCCESSFUL COMPLETION OF EXAMS.

SUBMITTING THE APPLICATION

SCOPE OF PRACTICE AND LEGAL CONSIDERATIONS

PERMITTED ACTIVITIES

PSYCHOLOGISTS MUST NOT ENGAGE IN ACTIVITIES RESERVED FOR OTHER LICENSED PROFESSIONALS, SUCH AS PRESCRIBING MEDICATION, UNLESS THEY HOLD ADDITIONAL QUALIFICATIONS. THEY ARE ALSO PROHIBITED FROM PRACTICING OUTSIDE THE SCOPE OF THEIR EXPERTISE OR ENGAGING IN FRAUDULENT BEHAVIOR.

CONFIDENTIALITY AND CLIENT RIGHTS

MARYLAND LAW MANDATES STRICT CONFIDENTIALITY REGARDING CLIENT INFORMATION, WITH EXCEPTIONS FOR MANDATORY REPORTING OR COURT ORDERS. PSYCHOLOGISTS MUST INFORM CLIENTS ABOUT THEIR RIGHTS AND OBTAIN INFORMED CONSENT FOR SERVICES.

CONTINUING EDUCATION AND LICENSE RENEWAL

MAINTAINING A MARYLAND PSYCHOLOGY LICENSE REQUIRES ADHERENCE TO CONTINUING EDUCATION REQUIREMENTS AND TIMELY RENEWAL TO ENSURE ONGOING COMPETENCE AND ADHERENCE TO PROFESSIONAL STANDARDS.

CONTINUING EDUCATION REQUIREMENTS

LICENSED PSYCHOLOGISTS MUST COMPLETE A MINIMUM OF 40 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS. THESE HOURS SHOULD INCLUDE ETHICS TRAINING AND BE APPROVED BY THE MARYLAND BOARD. RELEVANT WORKSHOPS, SEMINARS, AND COURSES CONTRIBUTE TO FULFILLING THIS REQUIREMENT.

RENEWAL PROCESS

LICENSE RENEWAL OCCURS BIENNIALY, WITH PSYCHOLOGISTS REQUIRED TO SUBMIT RENEWAL APPLICATIONS ALONG WITH PROOF OF COMPLETED CONTINUING EDUCATION AND APPLICABLE FEES. FAILURE TO RENEW ON TIME MAY RESULT IN LICENSE SUSPENSION OR ADDITIONAL PENALTIES.

INACTIVE AND RETIRED STATUS

PSYCHOLOGISTS WHO ARE NOT ACTIVELY PRACTICING MAY APPLY FOR INACTIVE STATUS TO MAINTAIN THEIR LICENSE WITHOUT MEETING CONTINUING EDUCATION REQUIREMENTS. RETIRED STATUS MAY ALSO BE AVAILABLE FOR THOSE PERMANENTLY CEASING PRACTICE.

PROFESSIONAL CONDUCT AND DISCIPLINARY ACTIONS

THE MARYLAND BOARD OF EXAMINERS OF PSYCHOLOGISTS ENFORCES STANDARDS OF PROFESSIONAL CONDUCT AND INVESTIGATES COMPLAINTS AGAINST LICENSED PSYCHOLOGISTS TO PROTECT PUBLIC SAFETY AND UPHOLD THE PROFESSION'S INTEGRITY.

ETHICAL STANDARDS

PSYCHOLOGISTS LICENSED IN MARYLAND MUST COMPLY WITH THE AMERICAN PSYCHOLOGICAL ASSOCIATION'S ETHICAL PRINCIPLES AND THE STATE'S SPECIFIC REGULATIONS. THESE STANDARDS COVER ISSUES SUCH AS CONFIDENTIALITY, COMPETENCE, DUAL RELATIONSHIPS, AND INFORMED CONSENT.

COMPLAINT AND INVESTIGATION PROCEDURES

THE BOARD REVIEWS COMPLAINTS SUBMITTED BY CLIENTS, EMPLOYERS, OR COLLEAGUES. INVESTIGATIONS MAY INVOLVE HEARINGS AND DISCIPLINARY ACTIONS IF VIOLATIONS ARE FOUND. DISCIPLINARY MEASURES RANGE FROM REPRIMANDS TO LICENSE SUSPENSION OR REVOCATION.

REPORTING OBLIGATIONS

PSYCHOLOGISTS ARE REQUIRED TO REPORT ANY UNETHICAL BEHAVIOR OR VIOLATIONS THEY OBSERVE WITHIN THE PROFESSION. FAILURE TO REPORT MAY RESULT IN DISCIPLINARY CONSEQUENCES.

WHAT HAPPENS IF CONTINUING EDUCATION REQUIREMENTS ARE NOT MET?

FAILURE TO COMPLETE CONTINUING EDUCATION CAN RESULT IN DENIAL OF LICENSE RENEWAL, SUSPENSION, OR OTHER DISCIPLINARY ACTIONS. LICENSEES ARE ENCOURAGED TO MAINTAIN ACCURATE RECORDS OF THEIR CONTINUING EDUCATION ACTIVITIES.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC REQUIREMENTS TO OBTAIN A PSYCHOLOGY LICENSE IN MARYLAND?

TO OBTAIN A PSYCHOLOGY LICENSE IN MARYLAND, APPLICANTS MUST HAVE A DOCTORAL DEGREE IN PSYCHOLOGY FROM AN ACCREDITED INSTITUTION, COMPLETE REQUIRED SUPERVISED PROFESSIONAL EXPERIENCE, PASS THE EXAMINATION FOR PROFESSIONAL PRACTICE IN PSYCHOLOGY (EPPP), AND PASS THE MARYLAND JURISPRUDENCE EXAM.

HOW MANY SUPERVISED HOURS ARE NEEDED FOR A PSYCHOLOGY LICENSE IN MARYLAND?

MARYLAND REQUIRES 3,500 HOURS OF SUPERVISED PROFESSIONAL EXPERIENCE, INCLUDING AT LEAST 1,750 HOURS OF DIRECT CLIENT CONTACT, COMPLETED OVER A MINIMUM OF TWO YEARS UNDER THE SUPERVISION OF A LICENSED PSYCHOLOGIST.

IS THE EPPP EXAM REQUIRED FOR MARYLAND PSYCHOLOGY LICENSURE?

YES, PASSING THE EXAMINATION FOR PROFESSIONAL PRACTICE IN PSYCHOLOGY (EPPP) IS MANDATORY FOR LICENSURE AS A PSYCHOLOGIST IN MARYLAND.
