ELIGIBILITY REQUIREMENTS

- COMPLETION OF SOME COLLEGE COURSEWORK OR A DEGREE
- MILITARY SERVICE
- RESIDENCY WITHIN THE MUNICIPALITY OR STATE
- PHYSICAL FITNESS STANDARDS COMPLIANCE

EXAM STRUCTURE AND CONTENT

THE MASSACHUSETTS POLICE EXAM IS CAREFULLY STRUCTURED TO EVALUATE VARIOUS COMPETENCIES ESSENTIAL FOR LAW ENFORCEMENT OFFICERS. UNDERSTANDING THE FORMAT AND CONTENT AREAS IS CRUCIAL FOR EFFECTIVE PREPARATION.

TEST FORMAT

STANDARDS VARY BY DEPARTMENT BUT GENERALLY ALIGN WITH GUIDELINES SET BY THE MP TC TO ENSURE CANDIDATES CAN MEET THE PHYSICAL DEMANDS OF THE JOB.

ADDITIONAL EVALUATIONS

OTHER ASSESSMENTS MAY INCLUDE:

- BACKGROUND CHECKS AND PSYCHOLOGICAL EVALUATIONS
- MEDICAL AND VISION EXAMS
- ORAL INTERVIEWS AND PANEL REVIEWS

APPLICATION AND TESTING PROCESS
