TO PASS THE MICHIGAN BAR EXAM, CANDIDATES MUST ACHIEVE A MINIMUM SCALED SCORE OF 270 OUT OF 400. THE SCORES FROM THE MBE AND WRITTEN PORTIONS ARE COMBINED TO CALCULATE THE TOTAL SCORE. MICHIGAN ALSO RECOGNIZES THE UBE SCORE FROM OTHER JURISDICTIONS, ALLOWING CANDIDATES TO TRANSFER SCORES IF THEY MEET SPECIFIC CRITERIA. HISTORICAL MICHIGAN BAR EXAM PASS RATES
