MISSISSIPPI PRAXIS WAIVED 2022 REFERS TO THE SPECIFIC CRITERIA AND POLICIES IMPLEMENTED BY THE STATE OF MISSISSIPPI IN THE YEAR 2022 REGARDING THE WAIVER OF PRAXIS TESTING REQUIREMENTS FOR TEACHER CERTIFICATION. OVERVIEW OF MISSISSIPPI PRAXIS WAIVER POLICY IN 2022

THE MISSISSIPPI PRAXIS WAIVED 2022 POLICY REPRESENTS A STRATEGIC ADJUSTMENT BY THE MISSISSIPPI DEPARTMENT OF EDUCATION TO ADDRESS TEACHER SHORTAGES AND STREAMLINE CERTIFICATION PROCESSES. TRADITIONALLY, PRAXIS EXAMS SERVE AS STANDARDIZED TESTS THAT ASSESS THE ACADEMIC SKILLS AND SUBJECT-SPECIFIC KNOWLEDGE OF TEACHER CANDIDATES. HOWEVER, IN 2022, MISSISSIPPI IMPLEMENTED WAIVERS THAT ALLOW CERTAIN APPLICANTS TO BE EXEMPT FROM THESE TESTING REQUIREMENTS BASED ON ALTERNATIVE QUALIFICATIONS. THIS POLICY CHANGE WAS PART OF A BROADER INITIATIVE TO INCREASE THE POOL OF CERTIFIED TEACHERS, PARTICULARLY IN AREAS EXPERIENCING CRITICAL STAFFING SHORTAGES.

THE WAIVER POLICY IS NOT A BLANKET EXEMPTION BUT IS CAREFULLY STRUCTURED TO MAINTAIN EDUCATIONAL STANDARDS WHILE FACILITATING ACCESS TO CERTIFICATION. IT REFLECTS MISSISSIPPI'S COMMITMENT TO BALANCING QUALITY ASSURANCE IN TEACHER PREPARATION WITH PRAGMATIC SOLUTIONS FOR WORKFORCE DEVELOPMENT. UNDERSTANDING THE SCOPE AND LIMITATIONS OF THE WAIVER IS ESSENTIAL FOR EDUCATORS SEEKING CERTIFICATION AND SCHOOL DISTRICTS PLANNING THEIR HIRING STRATEGIES.

ELIGIBILITY CRITERIA FOR THE MISSISSIPPI PRAXIS WAIVER

TO QUALIFY FOR THE MISSISSIPPI PRAXIS WAIVED 2022 STATUS, APPLICANTS MUST MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE STATE EDUCATION AUTHORITIES. THESE CRITERIA ENSURE THAT WHILE PRAXIS TESTING IS WAIVED, THE CANDIDATE'S QUALIFICATIONS AND EXPERIENCE ADEQUATELY DEMONSTRATE READINESS FOR CLASSROOM RESPONSIBILITIES.

ACADEMIC QUALIFICATIONS

APPLICANTS GENERALLY MUST HOLD A BACHELOR'S DEGREE FROM AN ACCREDITED INSTITUTION, OFTEN IN THE AREA OF INTENDED CERTIFICATION. SOME CANDIDATES WITH ADVANCED DEGREES OR DEMONSTRATED SUBJECT-MATTER EXPERTISE MAY ALSO BE

ELIGIBLE FOR THE WAIVER.

ALTERNATIVE CERTIFICATION PROGRAMS

CANDIDATES ENROLLED IN OR COMPLETING CERTAIN STATE-APPROVED ALTERNATIVE CERTIFICATION PROGRAMS MAY BE GRANTED A WAIVER. THESE PROGRAMS TYPICALLY EMPHASIZE PRACTICAL TEACHING SKILLS AND CLASSROOM EXPERIENCE OVER STANDARDIZED TESTING PERFORMANCE.

WORK EXPERIENCE AND DEMONSTRATED COMPETENCY

IN SOME CASES, RELEVANT TEACHING EXPERIENCE OR PROFESSIONAL ACCOMPLISHMENTS IN THE SUBJECT AREA CAN SUFFICE TO WAIVE THE PRAXIS REQUIREMENT. FOR EXAMPLE, CAREER CHANGERS WITH SUBSTANTIAL EXPERTISE IN STEM FIELDS MIGHT QUALIFY UNDER THIS PROVISION.

HIGH-NEED SUBJECT AREAS

WAIVERS ARE OFTEN PRIORITIZED FOR CANDIDATES INTENDING TO TEACH IN HIGH-DEMAND SUBJECTS SUCH AS MATHEMATICS, SCIENCE, SPECIAL EDUCATION, AND BILINGUAL EDUCATION. THIS TARGETED APPROACH SUPPORTS THE STATE'S EFFORTS TO FILL CRITICAL VACANCIES.

- ENROLLMENT IN STATE-APPROVED ALTERNATIVE CERTIFICATION
- DOCUMENTED TEACHING OR PROFESSIONAL EXPERIENCE
- INTENT TO TEACH IN DESIGNATED HIGH-NEED AREAS

APPLICATION PROCESS AND REQUIRED DOCUMENTATION

THE APPLICATION PROCESS FOR THE MISSISSIPPI PRAXIS WAIVED 2022 INVOLVES SUBMITTING FORMAL REQUESTS TO THE MISSISSIPPI DEPARTMENT OF EDUCATION, ACCOMPANIED BY SUPPORTING DOCUMENTATION THAT VERIFIES ELIGIBILITY. THIS PROCESS MUST BE FOLLOWED DILIGENTLY TO ENSURE TIMELY REVIEW AND APPROVAL.

APPLICATION SUBMISSION
