WHO CAN JOIN?

MEMBERSHIP IS OPEN TO A DIVERSE GROUP INCLUDING AUTISTIC INDIVIDUALS, FAMILY MEMBERS, EDUCATORS, HEALTHCARE PROFESSIONALS, AND ANYONE INTERESTED IN AUTISM ADVOCACY. THIS INCLUSIVITY ENSURES THAT THE MEMBERSHIP REFLECTS A BROAD SPECTRUM OF EXPERIENCES AND PERSPECTIVES, ENRICHING THE COMMUNITY AND ENHANCING RESOURCE SHARING.

INDIVIDUAL MEMBERSHIP IS SUITABLE FOR AUTISTIC PEOPLE OR SUPPORTERS WHO WANT DIRECT ACCESS TO ALL RESOURCES AND COMMUNITY ACTIVITIES. THIS TYPE OF MEMBERSHIP OFTEN INCLUDES ACCESS TO NEWSLETTERS, EXPERT ADVICE, AND DISCOUNTED EVENT FEES.

FAMILY MEMBERSHIP

FAMILY MEMBERSHIP IS DESIGNED FOR RELATIVES AND CAREGIVERS OF AUTISTIC INDIVIDUALS. IT PROVIDES SPECIALIZED GUIDANCE ON MANAGING DAILY CHALLENGES, EDUCATIONAL SUPPORT, AND ACCESS TO FAMILY-FOCUSED EVENTS AND WORKSHOPS.

PROFESSIONAL MEMBERSHIP

PROFESSIONALS WORKING IN HEALTHCARE, EDUCATION, OR SOCIAL SERVICES CAN OPT FOR PROFESSIONAL MEMBERSHIP. THIS CATEGORY OFFERS ADVANCED TRAINING MATERIALS, RESEARCH UPDATES, AND NETWORKING OPPORTUNITIES WITH OTHER EXPERTS IN THE FIELD.

ORGANIZATIONAL MEMBERSHIP

ORGANIZATIONS THAT SUPPORT AUTISTIC PEOPLE OR PROVIDE RELATED SERVICES CAN ALSO JOIN AS MEMBERS. THIS ALLOWS INSTITUTIONS TO ACCESS COLLECTIVE RESOURCES, COLLABORATE ON ADVOCACY PROJECTS, AND PROMOTE BEST PRACTICES WITHIN THEIR TEAMS.

ARE THERE ANY COSTS ASSOCIATED WITH NATIONAL AUTISTIC SOCIETY MEMBERSHIP?

YES, THERE IS A MEMBERSHIP FEE WHICH VARIES DEPENDING ON THE TYPE OF MEMBERSHIP CHOSEN. THE SOCIETY OFTEN OFFERS DIFFERENT LEVELS OF MEMBERSHIP, INCLUDING CONCESSIONS OR DISCOUNTS FOR CERTAIN GROUPS.
