IT IS HIGHLY RECOMMENDED TO COMPLETE THE REGISTRATION AT LEAST 24 TO 48 HOURS BEFORE TRAVEL TO AVOID DELAYS OR ISSUES AT IMMIGRATION CHECKPOINTS.

IMPORTANT TIPS FOR A SMOOTH REGISTRATION

TRAVELERS SHOULD KEEP THE FOLLOWING TIPS IN MIND TO ENSURE A SMOOTH AND HASSLE-FREE REGISTRATION PROCESS:

- USE A RELIABLE INTERNET CONNECTION TO AVOID DISRUPTIONS DURING FORM SUBMISSION.
- DOUBLE-CHECK ALL ENTERED INFORMATION FOR ACCURACY TO PREVENT ERRORS.

REQUIREMENTS FOR ONE HEALTH PASS PHILIPPINES

- INTENDED ADDRESS OR ACCOMMODATION IN THE PHILIPPINES

HEALTH AND COVID-19 RELATED DOCUMENTS

HEALTH DOCUMENTATION REQUIREMENTS VARY DEPENDING ON THE TRAVELER'S VACCINATION STATUS, ORIGIN, AND THE CURRENT HEALTH PROTOCOLS ENFORCED BY PHILIPPINE AUTHORITIES. COMMONLY REQUIRED DOCUMENTS INCLUDE:

- PROOF OF FULL COVID-19 VACCINATION (VACCINE CARD OR CERTIFICATE)
- NEGATIVE COVID-19 TEST RESULT (RT-PCR OR ANTIGEN TEST) TAKEN WITHIN THE PRESCRIBED TIMEFRAME
- MEDICAL CLEARANCE OR HEALTH CERTIFICATE IF APPLICABLE

IS THERE A FEE TO REGISTER FOR THE ONE HEALTH PASS PHILIPPINES?
