IT SEEKS TO CLOSE LOOPHOLES THAT ALLOWED PROBLEMATIC EMPLOYEES TO EVADE ACCOUNTABILITY BY SHIFTING JOB LOCATIONS RATHER THAN FACING DISCIPLINARY MEASURES. UNDERSTANDING THE LAW'S HISTORICAL CONTEXT REVEALS ITS IMPORTANCE IN PROMOTING SAFER SCHOOL ENVIRONMENTS AND PROTECTING STUDENTS FROM POTENTIAL ABUSE OR NEGLECT.

HISTORICAL CONTEXT

INFORMATION SHARING PROTOCOLS
