CHARACTERISTICS OF PROCEDURAL TEXTS

PROCEDURAL WRITING TYPICALLY FEATURES SEVERAL DISTINCT CHARACTERISTICS:

- CLEAR, CONCISE LANGUAGE TO AVOID AMBIGUITY.
- LOGICAL SEQUENCE OF STEPS PRESENTED IN ORDER.

BEFORE THE PROCEDURAL STEPS BEGIN, IT IS COMMON TO PRESENT A LIST OF MATERIALS, TOOLS, OR PREREQUISITES NEEDED TO

COMPLETE THE TASK. THIS ENSURES THAT READERS ARE PREPARED AND CAN FOLLOW THE INSTRUCTIONS WITHOUT INTERRUPTION.

STEP-BY-STEP INSTRUCTIONS

THE CORE OF PROCEDURAL WRITING IS THE STEP-BY-STEP INSTRUCTIONS, WHICH MUST BE LOGICALLY ORDERED AND EASY TO FOLLOW. EACH STEP USUALLY BEGINS WITH AN ACTION VERB AND INCLUDES SUFFICIENT DETAIL TO AVOID CONFUSION.

WARNINGS AND TIPS

INCLUDING WARNINGS OR SAFETY PRECAUTIONS IS ESSENTIAL WHEN PROCEDURES INVOLVE RISKS. TIPS OR ADDITIONAL NOTES MAY ALSO BE PROVIDED TO ENHANCE UNDERSTANDING OR IMPROVE OUTCOMES.
