OVERVIEW OF PROVIDENCE RI CRIME RATE STATISTICS

COMMON TYPES OF CRIMES IN PROVIDENCE

PROVIDENCE EXPERIENCES A RANGE OF CRIMINAL ACTIVITIES, WITH CERTAIN OFFENSES OCCURRING MORE FREQUENTLY THAN
