ELIGIBILITY REQUIREMENTS FOR RENEWAL

TO RENEW A PHYSICAL THERAPY LICENSE IN MICHIGAN, APPLICANTS MUST FIRST ENSURE THEY MEET THE STATE'S ELIGIBILITY CRITERIA. THE MICHIGAN BOARD OF PHYSICAL THERAPY REQUIRES THAT LICENSEES BE IN GOOD STANDING WITHOUT ANY UNRESOLVED DISCIPLINARY ACTIONS. ADDITIONALLY, THE LICENSEE MUST HAVE COMPLETED ALL REQUIRED CONTINUING EDUCATION CREDITS AS MANDATED BY STATE LAW. ONLY THOSE WITH AN ACTIVE LICENSE THAT IS NOT EXPIRED BEYOND A SPECIFIC GRACE PERIOD ARE ELIGIBLE TO APPLY FOR RENEWAL. FAILURE TO MEET THESE ELIGIBILITY REQUIREMENTS MAY RESULT IN DENIAL OF THE RENEWAL APPLICATION OR ADDITIONAL CORRECTIVE STEPS BEFORE REINSTATEMENT IS POSSIBLE.

GOOD STANDING AND DISCIPLINARY STATUS

LICENSEES MUST VERIFY THAT THEY DO NOT HAVE ANY PENDING COMPLAINTS OR DISCIPLINARY SANCTIONS AGAINST THEIR LICENSE. THE MICHIGAN DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS (LARA) MAINTAINS RECORDS OF ANY DISCIPLINARY ACTIONS. ENSURING A CLEAN PROFESSIONAL RECORD IS ESSENTIAL BEFORE INITIATING THE RENEWAL PROCESS.

LICENSE EXPIRATION AND GRACE PERIOD

MICHIGAN PHYSICAL THERAPY LICENSES TYPICALLY EXPIRE EVERY TWO YEARS. APPLICANTS SHOULD BE AWARE OF THE EXPIRATION DATE AND THE ALLOWABLE GRACE PERIOD FOR RENEWAL. RENEWING WITHIN THIS TIMEFRAME PREVENTS THE LICENSE FROM BECOMING INACTIVE AND AVOIDS THE NEED FOR REAPPLICATION OR ADDITIONAL FEES.

RENEWAL APPLICATION PROCESS

THE PROCESS TO RENEW A PHYSICAL THERAPY LICENSE IN MICHIGAN IS DESIGNED TO BE STRAIGHTFORWARD, BUT IT REQUIRES CAREFUL ATTENTION TO DETAIL. THE APPLICATION CAN BE SUBMITTED ONLINE THROUGH THE MICHIGAN LARA WEBSITE OR VIA MAIL BY COMPLETING THE OFFICIAL RENEWAL FORM. ONLINE RENEWAL

RENEWING ONLINE IS THE MOST EFFICIENT METHOD, ALLOWING APPLICANTS TO QUICKLY COMPLETE THE FORM, UPLOAD NECESSARY DOCUMENTS, AND PAY FEES ELECTRONICALLY. THE ONLINE SYSTEM PROVIDES IMMEDIATE CONFIRMATION AND STATUS UPDATES ON THE APPLICATION.

PAPER RENEWAL

FOR THOSE WHO PREFER OR REQUIRE PAPER SUBMISSION, THE RENEWAL FORM CAN BE PRINTED FROM THE MICHIGAN LARA WEBSITE. COMPLETED FORMS MUST BE MAILED TO THE SPECIFIED ADDRESS ALONG WITH PAYMENT. PROCESSING TIMES FOR PAPER APPLICATIONS ARE TYPICALLY LONGER THAN ONLINE SUBMISSIONS.

CONTINUING EDUCATION REQUIREMENTS

ONE OF THE CRITICAL COMPONENTS OF RENEWING A PHYSICAL THERAPY LICENSE IN MICHIGAN IS FULFILLING CONTINUING EDUCATION (CE) OBLIGATIONS. THESE REQUIREMENTS ENSURE THAT LICENSEES REMAIN CURRENT WITH ADVANCEMENTS IN PHYSICAL THERAPY PRACTICES AND MAINTAIN PROFESSIONAL COMPETENCY.

REQUIRED CE HOURS

PHYSICAL THERAPISTS IN MICHIGAN MUST COMPLETE A MINIMUM OF 30 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS. THIS INCLUDES COURSES RELEVANT TO CLINICAL PRACTICE, ETHICS, OR PROFESSIONAL DEVELOPMENT.

APPROVED CE PROVIDERS

CE COURSES MUST BE OBTAINED FROM PROVIDERS APPROVED BY THE MICHIGAN BOARD OF PHYSICAL THERAPY OR RECOGNIZED PROFESSIONAL ORGANIZATIONS. DOCUMENTATION OF COMPLETED HOURS MUST BE RETAINED AND MAY BE REQUESTED DURING THE RENEWAL PROCESS.

REPORTING CE CREDITS

APPLICANTS ARE REQUIRED TO REPORT THEIR CONTINUING EDUCATION CREDITS ACCURATELY ON THE RENEWAL APPLICATION AND CERTIFY THAT ALL INFORMATION IS TRUTHFUL. FAILURE TO MEET CE REQUIREMENTS CAN RESULT IN RENEWAL DENIAL OR DISCIPLINARY ACTION.

FEES AND PAYMENT METHODS

RENEWING A PHYSICAL THERAPY LICENSE IN MICHIGAN INVOLVES PAYMENT OF A RENEWAL FEE DETERMINED BY THE STATE LICENSING BOARD. UNDERSTANDING THE FEE STRUCTURE AND AVAILABLE PAYMENT METHODS HELPS ENSURE TIMELY PROCESSING OF THE APPLICATION.

RENEWAL FEE AMOUNT

THE STANDARD RENEWAL FEE FOR PHYSICAL THERAPY LICENSES IN MICHIGAN IS SET BY LARA AND IS SUBJECT TO CHANGE. APPLICANTS SHOULD VERIFY THE CURRENT FEE BEFORE SUBMITTING THEIR APPLICATION TO AVOID DELAYS.

ACCEPTED PAYMENT METHODS

PAYMENTS CAN BE MADE VIA CREDIT/DEBIT CARD FOR ONLINE RENEWALS OR BY CHECK OR MONEY ORDER WHEN SUBMITTING A PAPER APPLICATION. THE STATE DOES NOT ACCEPT CASH PAYMENTS FOR LICENSE RENEWAL.

RENEWAL DEADLINES AND LATE RENEWAL CONSEQUENCES

ADHERING TO RENEWAL DEADLINES IS VITAL TO MAINTAINING AN ACTIVE PHYSICAL THERAPY LICENSE IN MICHIGAN. THE STATE SETS SPECIFIC EXPIRATION DATES AND A GRACE PERIOD DURING WHICH RENEWAL IS ACCEPTED WITHOUT PENALTY.

RENEWAL DEADLINE

LICENSES MUST BE RENEWED BY THE EXPIRATION DATE, WHICH OCCURS BIENNIALY. THE EXACT DATE IS TYPICALLY THE LAST DAY OF THE LICENSEE'S BIRTH MONTH.

GRACE PERIOD AND LATE FEES

A GRACE PERIOD OF 30 DAYS FOLLOWING THE EXPIRATION DATE ALLOWS FOR LATE RENEWAL, USUALLY ACCOMPANIED BY AN ADDITIONAL LATE FEE. FAILURE TO RENEW WITHIN THIS TIMEFRAME RESULTS IN LICENSE EXPIRATION AND MAY REQUIRE REAPPLICATION AND FULFILLMENT OF ADDITIONAL REQUIREMENTS.

TIPS FOR A SUCCESSFUL LICENSE RENEWAL

TO ENSURE A SMOOTH AND TIMELY RENEWAL OF A PHYSICAL THERAPY LICENSE IN MICHIGAN, CONSIDER THE FOLLOWING BEST PRACTICES:

- START THE RENEWAL PROCESS WELL BEFORE THE EXPIRATION DATE TO ALLOW TIME FOR GATHERING DOCUMENTATION AND COMPLETING CONTINUING EDUCATION.
- KEEP THOROUGH RECORDS OF ALL CONTINUING EDUCATION ACTIVITIES AND RECEIPTS FOR VERIFICATION PURPOSES.
- DOUBLE-CHECK ALL APPLICATION INFORMATION FOR ACCURACY BEFORE SUBMISSION TO AVOID PROCESSING DELAYS.
- USE THE ONLINE RENEWAL SYSTEM WHENEVER POSSIBLE FOR FASTER PROCESSING AND IMMEDIATE CONFIRMATION.
- STAY INFORMED ABOUT ANY CHANGES IN RENEWAL REQUIREMENTS OR FEES BY REGULARLY CHECKING OFFICIAL STATE COMMUNICATIONS.

FREQUENTLY ASKED QUESTIONS

FAILURE TO MEET CONTINUING EDUCATION REQUIREMENTS CAN RESULT IN DENIAL OF THE RENEWAL APPLICATION. LICENSEES MAY NEED TO COMPLETE THE REQUIRED HOURS BEFORE RESUBMITTING OR FACE DISCIPLINARY ACTIONS.

IS THERE AN OPTION FOR REINSTATEMENT IF MY LICENSE LAPSES?

YES, MICHIGAN OFFERS REINSTATEMENT PROCEDURES FOR LICENSES THAT HAVE LAPSED BEYOND THE RENEWAL PERIOD. THIS PROCESS GENERALLY INVOLVES SUBMITTING AN APPLICATION, PAYING FEES, AND DEMONSTRATING COMPLIANCE WITH CONTINUING EDUCATION AND OTHER REQUIREMENTS.

WHAT ARE THE CONTINUING EDUCATION REQUIREMENTS FOR RENEWING A PHYSICAL THERAPY LICENSE IN MICHIGAN?

MICHIGAN REQUIRES PHYSICAL THERAPISTS TO COMPLETE 24 HOURS OF CONTINUING EDUCATION DURING EACH TWO-YEAR RENEWAL PERIOD, INCLUDING AT LEAST 2 HOURS RELATED TO ETHICS OR MICHIGAN LAWS AND RULES.

WHEN DOES A PHYSICAL THERAPY LICENSE EXPIRE IN MICHIGAN?

A PHYSICAL THERAPY LICENSE IN MICHIGAN EXPIRES ON THE LAST DAY OF THE LICENSEE'S BIRTH MONTH EVERY TWO YEARS.

CAN I RENEW MY MICHIGAN PHYSICAL THERAPY LICENSE IF IT HAS EXPIRED?

YES, YOU CAN RENEW AN EXPIRED MICHIGAN PHYSICAL THERAPY LICENSE WITHIN A GRACE PERIOD BY SUBMITTING A LATE RENEWAL APPLICATION AND PAYING ANY APPLICABLE LATE FEES. IF THE LICENSE HAS BEEN EXPIRED FOR AN EXTENDED PERIOD, REACTIVATION REQUIREMENTS MAY APPLY.

WHERE DO I SUBMIT MY RENEWAL APPLICATION FOR A MICHIGAN PHYSICAL THERAPY LICENSE?

RENEWAL APPLICATIONS FOR A MICHIGAN PHYSICAL THERAPY LICENSE ARE SUBMITTED ONLINE THROUGH THE MICHIGAN LARA WEBSITE VIA THE MILOGIN OR MIPLUS SYSTEM.

WHAT IS THE FEE TO RENEW A PHYSICAL THERAPY LICENSE IN MICHIGAN?

THE RENEWAL FEE FOR A PHYSICAL THERAPY LICENSE IN MICHIGAN IS TYPICALLY AROUND \$100 TO \$150, BUT IT IS BEST TO CHECK THE CURRENT FEE ON THE MICHIGAN LARA WEBSITE AS FEES CAN CHANGE.
