UNDERSTANDING RHETORICAL ANALYSIS IN MUSIC

DEFINITION AND PURPOSE

RHETORICAL ANALYSIS IS THE PRACTICE OF BREAKING DOWN A PIECE OF COMMUNICATION TO UNDERSTAND HOW ITS COMPONENTS CONTRIBUTE TO ITS OVERALL EFFECT. - **LOGOS:** USES LOGICAL ARGUMENTS OR STORYTELLING TO CONVEY A MESSAGE.

OTHER COMMON DEVICES

BEYOND THE APPEALS, SONGWRITERS OFTEN INCORPORATE VARIOUS STYLISTIC AND RHETORICAL TECHNIQUES, INCLUDING:

- **METAPHOR AND SIMILE:** COMPARING CONCEPTS TO CREATE VIVID IMAGERY.
- **REPETITION:** REINFORCING THEMES OR EMOTIONS.
- **ALLITERATION AND ASSONANCE:** CREATING MUSICALITY AND EMPHASIS WITHIN LYRICS.
- **IMAGERY:** USING DESCRIPTIVE LANGUAGE TO PAINT MENTAL PICTURES.
- **IRONY:** CONVEYING MEANING OPPOSITE TO THE LITERAL WORDS FOR EFFECT.

STEP-BY-STEP GUIDE TO ANALYZING A SONG

PERFORMING A THOROUGH RHETORICAL ANALYSIS OF A SONG EXAMPLE REQUIRES SYSTEMATIC EXAMINATION OF ITS COMPONENTS. THE FOLLOWING STEPS PROVIDE A STRUCTURED APPROACH.

STEP 1: LISTEN ACTIVELY

DETERMINE WHERE THE SONG APPEALS TO ETHOS, PATHOS, AND LOGOS. ANALYZE HOW THESE APPEALS ARE CONSTRUCTED THROUGH BOTH LYRICS AND MUSIC.

STEP 4: ANALYZE MUSICAL ELEMENTS

CONSIDER HOW MELODY, HARMONY, RHYTHM, TEMPO, AND INSTRUMENTATION CONTRIBUTE TO THE RHETORICAL EFFECT. NOTE MOMENTS WHERE MUSIC INTENSIFIES OR CONTRASTS WITH THE LYRICS.

STEP 5: CONTEXTUALIZE THE SONG

RESEARCH THE ARTIST'S BACKGROUND, THE SONG'S HISTORICAL CONTEXT, AND ITS INTENDED AUDIENCE TO ENRICH YOUR ANALYSIS.

STEP 6: SYNTHESIZE FINDINGS

COMBINE INSIGHTS FROM LYRICAL AND MUSICAL ANALYSIS TO ARTICULATE HOW THE SONG EFFECTIVELY COMMUNICATES ITS MESSAGE OR INFLUENCES LISTENERS.

EXAMPLE OF RHETORICAL ANALYSIS OF A SONG

LOGOS AND LOGICAL APPEAL

THE SONG'S LYRICS PRESENT A LOGICAL ARGUMENT, ASKING LISTENERS TO CONSIDER THE POSSIBILITY OF A BETTER WORLD. IT CHALLENGES EXISTING SOCIETAL NORMS BY PROPOSING A VISION BASED ON UNITY AND SHARED HUMANITY.

USE OF REPETITION AND IMAGERY

REPETITION OF THE WORD "IMAGINE" SERVES TO REINFORCE THE CENTRAL THEME AND INVITES CONTINUAL REFLECTION. VIVID IMAGERY, SUCH AS "NO COUNTRIES" AND "NO POSSESSIONS," HELPS LISTENERS VISUALIZE THE IDEAL WORLD LENNON DESCRIBES.

MUSICAL ELEMENTS ENHANCING RHETORIC

THE SIMPLICITY OF THE SONG'S ARRANGEMENT ALLOWS THE MESSAGE TO STAND AT THE FOREFRONT. THE SLOW TEMPO AND SUSTAINED NOTES CREATE A CONTEMPLATIVE MOOD, ENCOURAGING THOUGHTFUL ENGAGEMENT WITH THE LYRICS.
