## HOW TO APPLY FOR SMALL BUSINESS GRANTS

## PREPARE REQUIRED DOCUMENTATION

ENSURE THE APPLICATION IS SUBMITTED BEFORE THE DEADLINE AND CONFIRM RECEIPT WITH THE GRANT PROVIDER. FOLLOWING UP MAY PROVIDE ADDITIONAL INSIGHTS OR OPPORTUNITIES FOR CLARIFICATION.
