EDUCATIONAL REQUIREMENTS FOR PHYSICAL THERAPY IN TEXAS

MEETING THE EDUCATIONAL STANDARDS FORMS THE FOUNDATION OF THE TEXAS STATE PHYSICAL THERAPY REQUIREMENTS. CANDIDATES MUST GRADUATE FROM A PHYSICAL THERAPY PROGRAM ACCREDITED BY THE COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION (CAPTE). TEXAS MANDATES THAT THE DEGREE MUST BE AT LEAST A DOCTOR OF PHYSICAL THERAPY (DPT) OR AN EQUIVALENT ADVANCED DEGREE RECOGNIZED BY THE STATE REGULATORY BOARD.

ACCREDITED DEGREE PROGRAMS

APPLICANTS ARE REQUIRED TO COMPLETE A CAPTE-ACCREDITED PROGRAM TO ENSURE THE EDUCATION MEETS THE NECESSARY ACADEMIC AND CLINICAL STANDARDS. THESE PROGRAMS TYPICALLY ENCOMPASS COMPREHENSIVE COURSEWORK IN ANATOMY, PHYSIOLOGY, BIOMECHANICS, AND CLINICAL PRACTICE. THE CURRICULUM IS DESIGNED TO PREPARE STUDENTS FOR THE DIVERSE DEMANDS OF PHYSICAL THERAPY PRACTICE IN TEXAS.

CLINICAL EXPERIENCE REQUIREMENTS

THE NPTE ASSESSES CANDIDATES' KNOWLEDGE AND SKILLS NECESSARY FOR ENTRY-LEVEL PHYSICAL THERAPY PRACTICE. SUCCESSFUL COMPLETION OF THIS EXAM IS A MANDATORY STEP IN THE TEXAS STATE PHYSICAL THERAPY REQUIREMENTS FOR LICENSURE.

JURISPRUDENCE EXAMINATION

IN ADDITION TO THE NPTE, TEXAS REQUIRES APPLICANTS TO PASS A JURISPRUDENCE EXAMINATION. APPLICATION SUBMISSION AND PROCESSING TIME

THE TBPTE ACCEPTS APPLICATIONS ELECTRONICALLY OR BY MAIL, WITH PROCESSING TIMES VARYING BASED ON COMPLETENESS AND VOLUME. IT IS ADVISABLE TO APPLY WELL IN ADVANCE OF ANY PLANNED PRACTICE START DATE TO ACCOMMODATE POTENTIAL ADMINISTRATIVE DELAYS.

CONTINUING EDUCATION AND LICENSE RENEWAL

MAINTAINING A PHYSICAL THERAPY LICENSE IN TEXAS REQUIRES ONGOING PROFESSIONAL DEVELOPMENT THROUGH CONTINUING EDUCATION (CE). THE STATE ENFORCES STRICT CE REQUIREMENTS TO ENSURE THAT PRACTITIONERS REMAIN CURRENT WITH

MEDICAL ADVANCES AND BEST PRACTICES.

CONTINUING EDUCATION REQUIREMENTS

LICENSED PHYSICAL THERAPISTS IN TEXAS MUST COMPLETE 24 HOURS OF APPROVED CONTINUING EDUCATION EVERY TWO YEARS. LICENSE RENEWAL PROCESS

RENEWAL APPLICATIONS MUST BE SUBMITTED BIENNIALY BEFORE THE LICENSE EXPIRATION DATE. PRACTITIONERS MUST CERTIFY COMPLETION OF THE REQUIRED CE HOURS AND PAY THE RENEWAL FEE. FAILURE TO MEET RENEWAL REQUIREMENTS CAN RESULT IN LICENSE SUSPENSION OR REVOCATION.

SCOPE OF PRACTICE

IN ADDITION TO THE NPTE, TEXAS REQUIRES CANDIDATES TO PASS THE TEXAS JURISPRUDENCE EXAM, WHICH TESTS KNOWLEDGE OF STATE LAWS AND RULES GOVERNING PHYSICAL THERAPY PRACTICE.

WHAT IS THE APPLICATION PROCESS FOR OBTAINING A PHYSICAL THERAPY LICENSE IN TEXAS?

APPLICANTS MUST SUBMIT A COMPLETED APPLICATION TO THE TEXAS BOARD OF PHYSICAL THERAPY EXAMINERS, INCLUDING OFFICIAL TRANSCRIPTS, NPTE SCORES, JURISPRUDENCE EXAM RESULTS, AND PAY THE REQUIRED FEES.
