THESE AID PROGRAMS AIM TO REDUCE THE FINANCIAL BURDEN ON STUDENTS AND THEIR FAMILIES WHILE PROMOTING ACADEMIC SUCCESS AND DEGREE COMPLETION. TOWSON UNIVERSITY'S FINANCIAL AID OFFICE SERVES AS A CENTRAL HUB FOR INFORMATION, COUNSELING, AND APPLICATION PROCESSING. STUDENTS ARE ENCOURAGED TO ENGAGE WITH FINANCIAL AID ADVISORS EARLY IN THEIR ACADEMIC CAREERS TO PLAN EFFECTIVELY AND SECURE THE MOST ADVANTAGEOUS AID PACKAGES.

TYPES OF FINANCIAL AID AVAILABLE

TOWSON UNIVERSITY OFFERS SEVERAL CATEGORIES OF FINANCIAL AID TO ACCOMMODATE DIVERSE STUDENT NEEDS. THESE INCLUDE MERIT-BASED SCHOLARSHIPS, NEED-BASED GRANTS, FEDERAL AND PRIVATE LOANS, AND WORK-STUDY OPPORTUNITIES. EACH TYPE OF AID HAS SPECIFIC CRITERIA, BENEFITS, AND OBLIGATIONS THAT STUDENTS SHOULD CAREFULLY CONSIDER.

SCHOLARSHIPS

SCHOLARSHIPS AT TOWSON ARE PRIMARILY MERIT-BASED AWARDS THAT RECOGNIZE ACADEMIC EXCELLENCE, LEADERSHIP, COMMUNITY SERVICE, AND SPECIAL TALENTS. THESE AWARDS DO NOT REQUIRE REPAYMENT AND CAN SIGNIFICANTLY REDUCE TUITION COSTS. THE UNIVERSITY OFFERS INSTITUTIONAL SCHOLARSHIPS, AS WELL AS ACCESS TO EXTERNAL SCHOLARSHIP PROGRAMS.

GRANTS

GRANTS ARE NEED-BASED FINANCIAL AWARDS THAT DO NOT REQUIRE REPAYMENT. TOWSON STUDENTS MAY QUALIFY FOR FEDERAL PELL GRANTS, STATE GRANTS SUCH AS THE MARYLAND STATE GRANT PROGRAM, AND INSTITUTIONAL GRANTS. THESE FUNDS ARE TYPICALLY ALLOCATED BASED ON DEMONSTRATED FINANCIAL NEED DETERMINED THROUGH THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA).

LOANS

LOANS PROVIDE NECESSARY FUNDS THAT MUST BE repaid WITH INTEREST AFTER GRADUATION OR WHEN THE STUDENT DROPS BELOW HALF-TIME ENROLLMENT. TOWSON FINANCIAL AID INCLUDES ACCESS TO FEDERAL STUDENT LOANS LIKE DIRECT SUBSIDIZED AND UNSUBSIDIZED LOANS, PLUS LOANS, AND PRIVATE LOAN OPTIONS. BORROWERS SHOULD CAREFULLY EVALUATE LOAN TERMS AND BORROW ONLY WHAT IS NECESSARY TO MINIMIZE DEBT BURDEN.

Work-Study Programs

THE FEDERAL WORK-STUDY PROGRAM ALLOWS ELIGIBLE STUDENTS TO WORK PART-TIME ON OR OFF CAMPUS TO EARN MONEY FOR EDUCATIONAL EXPENSES. THIS PROGRAM HELPS DEVELOP PROFESSIONAL SKILLS WHILE PROVIDING FINANCIAL SUPPORT. TOWSON'S CAREER SERVICES ASSIST STUDENTS IN FINDING SUITABLE WORK-STUDY POSITIONS ALIGNED WITH THEIR ACADEMIC AND CAREER GOALS.

APPLICATION PROCESS FOR TOWSON FINANCIAL AID

APPLYING FOR TOWSON FINANCIAL AID INVOLVES SEVERAL STEPS THAT MUST BE COMPLETED ACCURATELY AND ON TIME. THE PRIMARY APPLICATION FOR MOST FEDERAL AND STATE AID IS THE FAFSA, WHICH COLLECTS FINANCIAL INFORMATION TO ASSESS ELIGIBILITY. TOWSON UNIVERSITY MAY ALSO REQUIRE ADDITIONAL INSTITUTIONAL FORMS OR DOCUMENTATION.

FILING THE FAFSA

THE FAFSA IS THE FOUNDATIONAL DOCUMENT FOR SECURING FEDERAL, STATE, AND INSTITUTIONAL FINANCIAL AID. STUDENTS SHOULD SUBMIT THE FAFSA AS EARLY AS POSSIBLE AFTER OCTOBER 1 EACH YEAR TO MAXIMIZE AID OPPORTUNITIES. THE FORM COLLECTS DATA ON FAMILY INCOME, ASSETS, AND HOUSEHOLD SIZE TO CALCULATE THE EXPECTED FAMILY CONTRIBUTION (EFC).

SUPPLEMENTAL TOWSON FORMS

IN SOME CASES, TOWSON FINANCIAL AID OFFICES REQUEST ADDITIONAL VERIFICATION DOCUMENTS OR INSTITUTIONAL AID APPLICATIONS. THESE MAY INCLUDE TAX TRANSCRIPTS, VERIFICATION WORKSHEETS, OR SCHOLARSHIP-SPECIFIC FORMS. PROMPT SUBMISSION ENSURES TIMELY PROCESSING AND AWARD NOTIFICATION.

DEADLINES AND TIMELINES

MEETING ALL FINANCIAL AID DEADLINES IS CRITICAL FOR ELIGIBILITY AND AWARD CONSIDERATION. TOWSON UNIVERSITY PUBLISHES SPECIFIC SUBMISSION DEADLINES FOR FAFSA, SCHOLARSHIP APPLICATIONS, AND SUPPLEMENTAL FORMS. STUDENTS SHOULD REGULARLY CHECK OFFICIAL COMMUNICATIONS TO AVOID MISSING IMPORTANT DATES.

ELIGIBILITY REQUIREMENTS

CITIZENSHIP AND RESIDENCY

TO QUALIFY FOR MOST FEDERAL AND STATE AID PROGRAMS, STUDENTS MUST BE U.S. CITIZENS OR ELIGIBLE NON-CITIZENS. MARYLAND RESIDENCY MAY ALSO BE REQUIRED FOR CERTAIN STATE GRANTS AND SCHOLARSHIPS. TOWSON'S FINANCIAL AID OFFICE CAN PROVIDE GUIDANCE ON RESIDENCY DOCUMENTATION AND ELIGIBILITY VERIFICATION.

ENROLLMENT STATUS

STUDENTS MUST BE ENROLLED AT LEAST HALF-TIME TO RECEIVE FEDERAL FINANCIAL AID. FULL-TIME ENROLLMENT MAY BE REQUIRED FOR SOME SCHOLARSHIPS AND INSTITUTIONAL GRANTS. PART-TIME STUDENTS SHOULD CONSULT WITH FINANCIAL AID ADVISORS TO UNDERSTAND HOW ENROLLMENT IMPACTS THEIR AID PACKAGES.

SATISFACTORY ACADEMIC PROGRESS

TOWSON UNIVERSITY ENFORCES SATISFACTORY ACADEMIC PROGRESS (SAP) STANDARDS TO ENSURE STUDENTS MAINTAIN ELIGIBILITY FOR FINANCIAL AID. THIS INCLUDES MAINTAINING A MINIMUM GPA, COMPLETING A PERCENTAGE OF ATTEMPTED CREDITS, AND PROGRESSING TOWARD DEGREE COMPLETION WITHIN A MAXIMUM TIMEFRAME. FAILURE TO MEET SAP REQUIREMENTS MAY RESULT IN SUSPENSION OF AID.

MAINTAINING FINANCIAL AID ELIGIBILITY

CONTINUOUS ELIGIBILITY FOR TOWSON FINANCIAL AID REQUIRES ONGOING COMPLIANCE WITH ACADEMIC AND ADMINISTRATIVE STANDARDS. STUDENTS SHOULD REMAIN INFORMED ABOUT THEIR RESPONSIBILITIES AND INSTITUTIONAL POLICIES TO AVOID INTERRUPTIONS IN AID.

ACADEMIC PERFORMANCE MONITORING

REGULAR EVALUATION OF GRADES AND CREDIT COMPLETION IS ESSENTIAL. STUDENTS ARE ENCOURAGED TO UTILIZE ACADEMIC SUPPORT SERVICES AND MAINTAIN COMMUNICATION WITH ADVISORS TO STAY ON TRACK WITH SAP REQUIREMENTS. EARLY INTERVENTION CAN PREVENT LOSS OF FINANCIAL AID ELIGIBILITY.

REPORTING CHANGES

STUDENTS MUST PROMPTLY REPORT SIGNIFICANT CHANGES IN ENROLLMENT STATUS, INCOME, OR FAMILY CIRCUMSTANCES TO THE FINANCIAL AID OFFICE. ACCURATE AND UPDATED INFORMATION ENSURES PROPER ADJUSTMENT OF AID PACKAGES AND PREVENTS OVER-AWARDS OR UNDER-AWARDS.

RENEWAL PROCEDURES

MOST FINANCIAL AID AWARDS REQUIRE ANNUAL RENEWAL THROUGH UPDATED FAFSA SUBMISSIONS AND POSSIBLE SUPPLEMENTAL APPLICATIONS. STUDENTS SHOULD FAMILIARIZE THEMSELVES WITH THE RENEWAL PROCESS AND DEADLINES TO CONTINUE RECEIVING AID SEAMLESSLY.

ADDITIONAL RESOURCES AND SUPPORT

TOWSON UNIVERSITY PROVIDES A VARIETY OF RESOURCES TO ASSIST STUDENTS IN MAXIMIZING THEIR FINANCIAL AID BENEFITS AND MANAGING EDUCATIONAL EXPENSES EFFECTIVELY. THESE SERVICES CONTRIBUTE TO A SUPPORTIVE ENVIRONMENT FOR ACADEMIC AND FINANCIAL SUCCESS.

FINANCIAL AID COUNSELING

STUDENTS MUST COMPLETE THE FREE APPLICATION FOR FEDERAL STUDENT AID (FAFSA) AT [FAFSA.GOV](https://fafsa.gov), LISTING TOWSON UNIVERSITY'S SCHOOL CODE 003936, TO BE CONSIDERED FOR FINANCIAL AID.

WHEN IS THE PRIORITY DEADLINE FOR FINANCIAL AID APPLICATIONS AT TOWSON?

THE PRIORITY DEADLINE FOR SUBMITTING THE FAFSA TO TOWSON UNIVERSITY IS TYPICALLY MARCH 1 EACH YEAR, BUT STUDENTS ARE ENCOURAGED TO APPLY AS EARLY AS POSSIBLE.

DOES TOWSON UNIVERSITY OFFER MERIT-BASED SCHOLARSHIPS?
