CONSEQUENCES OF FAILING THE POLICE WRITTEN EXAM

HOWEVER, FAILURE AT THIS STAGE DOES NOT NECESSARILY CLOSE THE DOOR PERMANENTLY; MANY DEPARTMENTS ALLOW MULTIPLE ATTEMPTS UNDER CERTAIN CONDITIONS.

IMMEDIATE IMPACT ON CANDIDACY

WHEN A CANDIDATE FAILS THE POLICE WRITTEN EXAM, THEIR APPLICATION IS USUALLY PUT ON HOLD OR REJECTED FOR THAT HIRING PERIOD. THIS MEANS THEY WILL NOT BE CONSIDERED FOR THE POSITION UNTIL THEY SUCCESSFULLY PASS THE EXAM IN A FUTURE TESTING WINDOW. THE FAILURE CAN AFFECT THE CANDIDATE'S CONFIDENCE AND TIMELINE BUT DOES NOT AUTOMATICALLY BAR THEM FROM EVER BECOMING A POLICE OFFICER.

EFFECT ON HIRING TIMELINE

THE NEED TO RETAKE THE EXAM CAN EXTEND THE OVERALL HIRING PROCESS BY MONTHS OR EVEN YEARS, DEPENDING ON THE FREQUENCY OF THE TESTING SCHEDULE AND DEPARTMENT POLICIES. CANDIDATES MUST REMAIN PREPARED AND PATIENT WHILE WAITING FOR THE NEXT OPPORTUNITY TO TAKE THE EXAM AGAIN.

RETAKE POLICIES AND APPLICATION IMPACT
