DEFINING ROI IN SPECIAL EDUCATION

THESE OUTCOMES TRANSLATE INTO LONG-TERM BENEFITS FOR STUDENTS WITH DISABILITIES, THEIR FAMILIES, AND SOCIETY AS A WHOLE.

ROI IN SPECIAL EDUCATION CAN BE UNDERSTOOD AS A RATIO OR COMPARISON BETWEEN THE INPUTS—SUCH AS FUNDING, STAFF TIME, AND MATERIALS—AND THE OUTCOMES GENERATED BY THESE INPUTS.
